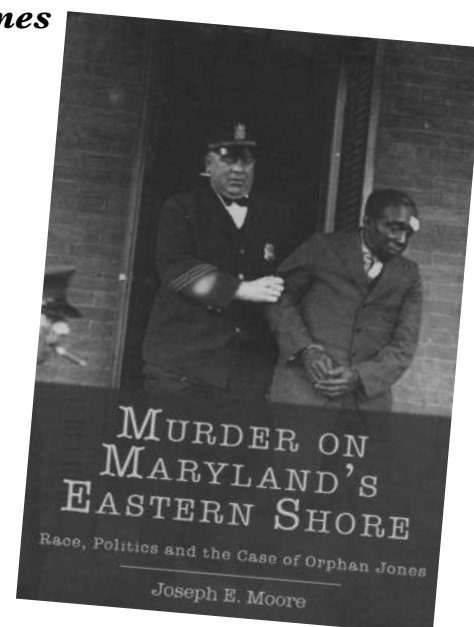
Murder on Maryland's Eastern Shore: Race, Politics and the Case of Orphan Jones

Joseph E. Moore, former Worcester County Maryland State's Attorney and Nabb board member, lectures on his recently published book *Murder on Maryland's Eastern Shore: Race, Politics and the Case of Orphan Jones* 2 p.m. Tuesday, October 10, in the Wicomico Room of Salisbury University's Guerrieri University Center.

His book explores the racially charged case of Euel Lee, alias Orphan Jones, an African-American worker accused of murdering his white employer and family in Worcester County, and the Depression-era politics surrounding his trial.

***Salisbury Advertiser* And Sussex County Microfilm**

The Nabb Center recently has acquired both microfilm and bound copies of the *Salisbury Advertiser*. The microfilms cover the earlier period from 1871 to 1918, while the bound papers cover the period 1934 to 1945, 1955 to 1970 and 1992 to 2002. However, neither time period contain a complete set of papers. Copies of the microfilm can be found on the microfilm wall under the Wicomico County section; the bound books will be stored elsewhere but can be brought to the Reading Room for viewing.

The Nabb Center also purchased over 100 rolls of microfilm from the Delaware State Archives for Sussex County, DE. These new resources were purchased through the Teaching American History Grant, a collaboration of the Wicomico County Board of Education, the Salisbury University Department of History and the Nabb Research Center.
