UCC Proposal on Higher Education General Information Survey (HEGIS) Codes in General Education (see documents) (Dr. Katherine Miller; see documents)

- At the previous Faculty Senate Meeting (February 10, 2015), the Senate passed Part A of the Proposal; today we are to consider Motion regarding Part B
- Discussion
 - Faculty Senate has final authority; proposed additions of HEGIS Code areas really should be considered by the Faculty Senate
 - Having a HEGIS Code is added/approved via UCC grants too much authority to a small committee that would have major impacts on the General Education curriculum
 - UCC already has a fully scheduled mandate with numerous proposals for new courses, major/minor tracks, changes to degree programs, etc., each semester;
 - To add new HEGIS Code proposals from various departments would be burdensome for UCC
 - UCC largely reviews technicalities; it does not review a course proposal's merit that is done at the school curriculum committee level
 - UCC does not contain a wide enough range of disciplinary expertise to judge HEGIS Code proposals
 - Majority of UCC's six members believe that UCC currently has the authority to review HEGIS Codes; but support among members of the small UCC is not unanimous
 - General Education HEGIS Code changes could be required to obtain input from all departments that currently comprise the particular GenEd group at the school level before reaching UCC
- Following discussion, the Faculty Senate voted to clarify UCC's authority:

— Currently UCC's authority is defined in the Curriculum Guide as: "The UCC reviews undergraduate curriculum proposals of two broad types: 1) new courses and course change proposals, and 2) new programs, majors or minors or changes in programs, majors or minors."

The Faculty Senate recently received a request to add a new HEGIS for inclusion in the General Education curriculum. In prepping this issue for Senate, I discovered we had created a procedure back in February 2015 and had unanimously approved a motion for a text change in the Curriculum Approval Guide. Apparently, this was not followed up with a formal Senate Recommendation to the Provost form, so I am doing so now.

As a heads-up, and related, we may soon (next Senate meeting on March 28 perhaps) have a second formal recommendation to add text in section 1.2 of the Curriculum Approval Guide to codify the procedure we crafted back in 2015 regarding the Faculty Role.
