36	members, department chairs and, on a more regular basis, members of the
37	administration. Not only does this display a lack of collegiality on the part of the
38	individual attacker(s), but the continued tolerance of such attacks runs the risk of an
39	appearance that the rest of the Senate as a whole approves of such behavior.
