"That, beginning in the semester before retirement, any retiring faculty can be nominated for the title of *Professor Emeritus* by any member of the Salisbury University Faculty via a brief letter of nomination to the provost and that the provost will forward those letters of nomination to the University Promotions Committee for their consideration during a meeting in the final semester of the retiring faculty member's service."

2. **Beginning in the semester before retirement**, faculty may be nominated for the title of *Professor Emeritus* by any member of the Salisbury University faculty via a brief letter of nomination to the provost.

3. The provost will forward letters of nomination to the Committee on Promotions for their consideration during ~~the annual faculty promotions process~~ **a meeting in the final semester of the faculty member's service. The Committee on Promotions may recommend that a retiring faculty member should be granted the title effective immediately on retirement."**
