Extral of a Letter from Mr. Patrick Dickson, at Barnard-Castle, in Yorkshire, dated August the 5th, 1752.

R. Philip Brown, Physician, who lives at present in my House at Barnard-Castle, was, in the Month of January, Laftle, was, in the Month of January, 1750, feized with a nervous Fever and Althma, and narrowly escaped the Pal sey in his Tongue: He had scarce well recovered this, when, in the Month of Angust, after being wet under a Shower, he was attacked by a very lapid Pleurisy, which in a few Days was succeeded by a nervous Fever and Ashma, attended with a numerous Train of the most dreadful Symptoms; so that for a Rortnight, it was difficult to say when fo that for a Fortnight, it was difficult to fay whether he was dead or alive. No fooner had he recovered a little, fo as to be able to fit up in Bed, than he was feized with a Palfey in his left Arm, which deprived him of all Motion and Sensation in it, the Athma still continued severe, and prevented his gaining Strength; to these Complaints was ad-ded, in a few Weeks, an hydropical Swelling of his Belly; the Ashma redoubled it's Attacks, seizhis Belly; the Afthma redoubled it's Attacks, lexing him twice or thrice a Day, and at last put on an epileptic Appearance; and in one of these Fits, in the Month of Ottober, 1750, he lost entirely the Use of his Tongue. Many were the Attempts to remove this unhappy Disorder, but all in vain. In February, 1751; I went with him to Edinburgh, where further Trial was made, but to no Purpose. Dr. John Rutherford, Professor of Medicine there, desired that the Electrical Machine might be tried, which was done. but snowthstanding the Slight. which was done, but (notwithstanding the Slightness of the Shocks he received), he found himself
considerably the worse for it: This probably might
have been owing to his great Weakness; for he
had not been able to stand for near eight Months,
and indeed he turned weaker daily. We returned

Two Days after I electrized his Tongue twice, and gave him two hundred Shocks each Time: They were fo ftrong, that he had al-most fallen down with the Violence; but every Shock gave him more Freedom in the Motion of his Tongue, which made him bear them with greater Chearfulness. He falivated greatly, discharged a vast Quantity from his Nose, his Eyes turned very hot, were much instance, and the sulphurous Taste was very strong in his Mouth. He now made as great Essorts as possible to speak, but could express nothing further than O, O. I examined more particularly into his Manner of Articulation, and found he had forgot how to place his Tongue, in order to express any Letter or Word. I then desired him to look catefully at me while I repeated the Alphabet, and gave him Directions for the placing of his Tongue to every Letter, and in about three thours he attained to a pretty diffind Pronunciation of the Alphabet, tho' he could pronounce fome Letters better than others; G. H, and X were very difficult: He came next to Syllables, then short Words, and upon electrining his Tongue

a few Times more, could fpeak any Word, Sentence, or Discourse, with the Help of his Finger, to make his Tongue touch the Palate of his Mouth. The more he spoke, he found his Tongue grow stronger; and in a few Hours more could speak as well and distinct as ever. He has now a Chearful ness and Vivacity greater than usual, and can endure the Fatigue of Walking, or any other Exercise, better than he could at any time since he was first taken ill. That this Cure was entirely owing to Electricity, may be cert inly depended upon; as he has used no Medicines for a long Time, tho his Health has been but very bad of late.

CADIZ, August 27.

We hear from Gibraltar, that Letters have been received there from Tetuan, with Advice of the Arrival of Capt. Steesis and his Crew at Fez, after a long and painful Murch, in which they underwent all Manner of Hardships. Their Food, during their whole March, consisted only of a little Rice or Flour and Water, with a very small Portion of black Bread.

Soon after their Arrival at Fez, the Emperor of Morocco fent for the Captain, and defired him to relate his Misfortunes; and Mr. Steenis perceiving that he was affected with the Account he gave him, embraced this Opportunity to affure him, how defirous the States General were to conclude the Peace which they had been fo many Years negotiating; and the Emperor answered in very favourable Terms. After this Captain Steenis begg'd him to determine the Affair of his Runsom, and that of his Crew, which the Emperor affured him he would immediately fend Orders to the Bashaw of Tetuan about. Capt. Steenis met with a great deal of Humanity in the Emperor, from whence he obtained much better Treatment for the Dutch Prisoners than they had heretofore met with, and their Labours render'd much less painful than it was at Tetuan. Moreover the Captain himself is entirely at his Liberty to go about Fez without any Guard.

Warfare, Sept. 16. Letters from the Ukrain advife, that the Haydamacks have made a fresh Incursion there, and have plunder'd the two Towns of Murachwa and Thiworow. The Peasants of Podolia are so irritated against these Robbers, that having taken two of them, they eaused one to be roasted alive.

Leghern, Sept. 8. The Island of Corsica is at present divided into three Factions; the first is that of the Republic; the second is the French Faction; and the third is newly formed, consisting of the Communities of the Center of the Island. This last, which opposes the other two, has just published a Manisesto, in the following Terms: "The critical Situation that this Island is in, makes it necessary for some affectionate Children of their Country to rise up, and shew that they are not de generated from the Virtues of their Ancestors: Let all those who have the Good of their Nation sincerely at Heart, demonstrate that they are worthy of the Name of Corsicans! Let those who call themselves Genoese, or by any other foreign Name, be looked upon as unworthy Sons who deny their own Mother! We cut them off from the Midst of us: We will have no Communication with them; and we lock upon them as cowardly Wretches, who have deviated from their Origin; we will purfue them wherever we find them, until they return to their Duty, and join us to defend the common Heritage of our Fathers. The Valour of the Corsicans is alone sufficient to deliver the Nation from

the Tyranay to which so many Attempts are made to subject it. It is solely from their Courage that the Re establishment of Peace and Prosperity is to be expected: All these therefore, whom the vain Hope of seeing a Pacification has seduced, ought to rectify their Error, and at length acknowledge, that every Nation who takes Foreigners for Arbiters, takes the first Step towards Slavery, and does not deserve to enjoy the Condition of Free Men."

Patrick, belonging to Liverpool, and put the Captain in Irons. The Pyrates proceeded with the Clayton to the Coast of Brazill, and there fold the Slaves, but they were taken together with the Effects, by the Portugueze Admiral, who was bringing them Prifoners to Lisbon, and had secured the Ship and Effects for the Benefit of the Owners.

"I take the Liberty to acquaint you of what happened in my Voyage to and from the Bay of Honduras, from whence I am now arriv'd in this Port, waiting for Orders where to proceed. In my Way to the Bay, on the 1st of May last, I called at the Musqueto Shore, in order to know how Matters were at the Bay, and immediately waited on Governor Pitt; who, to my Surprize, informed me that most of the Bay Men were there, being dally routed by the Spaniards. I saw like-wise on Shore sinsteen Masters of Vessels, and eighty odd Seamen that had been taken by the Spaniards, and by them set on Shore almost naked, and that there were about five Families less in the Bay. The Spaniards had Intelligence of my co-ming to supply the Bay Men with Provisions, and the Strength of my Ship, and of this being the third Voyage she made to the Bay; which Information they had by some Renegadoe; that entered with them, of which there are a great many, intimidated and forced by their ill Utage, and encouraged by the great Shares they promise them out of the Prizes. They told me I should run a monstrous Risque in going to the Bay; but not knowing where este to go, I resolved to run the Hazard, being encouraged by the Bay Men, who offered to go with me, and my Ship being able to stand a Brush, having twelve Six Pounders, and well provided with other Implements of Defence. Accordingly I took on board 40 Bay Men, and then mussered better than 70 able Men; however, notwithstanding I strove all I could to avoid meeting with the Cruizers, but to no Purpose; for about 7 Hours after I lest the Shore, I met, off Rattan, a Galley hoisting Spanish Colours; She soon came up with me, and then we engaged one another very warmly, from Rieven in the Morning till after Three in the Asternoon. We received no other Damage than one Shot which hull'd us, the Sprit Sail Yards shot in several Places, and one Shot which took away the fore Patt of my Shirt, and grazed across my Belly, and had I been more corpulent, should have had they been more Condition. One of her Co

accompany them should go overboard. S. and coming off English Harbour, they fired several Guns, as Signals of Diffress, which brought Boats to their Affiltance: On the Prople's coming on board, Capt. Saunders preferred his Complaint against the above mentioned Men, who were fecured in Irons. and after the now's anchoring in Falmouth Har bour, conveyed on board his Majesty's Ship Advice, then lying at English Harbour, in order for their Appearance at the Bar. — Soon after the Snow's Arrival, the Produce of Part of her Cargo (being about fixty or feventy Slaves) and what remain'd, was fold for the Benefit of her Owners or Infuters; who, 'tis faid, will be great Losers.

CADIZ, August 27.

E hear from Gibraltar, that Letters have been received there from Tetuan, with Advice of the Arrival of Capt. Steenis and his Crew at Fez, after a long and painful March, in which they underwent all Mainer of Hardships. Their Food, during their whole March, confitted only of a little Rice or Flour and Water, with a

very small Portion of black Bread. Soon after their Arrival at Fez, the Emperor of Morocco fent for the Captain, and defired him to relate his Misfortunes; and Mr. Steenis perceiving that he was affected with the Account he gave him, embraced this Opportunity to affure him, how defirous the States General were to conclude the Peace which they had been fo many Years negotiating; and the Emperor answered in very favou-rable Terms. After this Captain Steenis begg'd him to determine the Affair of his Ranfom, and that of his Crew, which the Emperor affured him he would immediately fend Orders to the Bashaw of Tetuan about. Capt. Steenis met with a great deal of Humanity in the Emperor, from whence he obtained much better Treatment for the Dutch Prisoners than they had heretofore met with, and their Labours render'd much less painful than it was at Tetuan. Moreover the Captain himself is entirely at his Liberty to go about Fez without any Guard.

Warfarw, Sept. 16. Letters from the Ukrain advise, that the Haydamacks have made a fresh Incursion there, and have plunder'd the two Towns of Murachwa and Thiworow. The Peafants of Podolia are so irritated against these Robbers, that having taken two of them, they caused one to be roasted alive.

Legborn, Sept. 8. The Island of Corfica is at present divided into three Factions; the first is that of the Republic ; the second is the French Faction ; and the third is newly formed, confisting of the Communities of the Center of the Island. This last, which opposes the other two, has just pub-lished a Manisesto, in the following Terms: "The critical Situation that this Island is in, makes it neceffary for fome affectionate Children of their Country to rife up, and shew that they are not de generated from the Virtues of their Ancestors : Let all those who have the Good of their Nation fincerely at Heart, demonstrate that they are worthy of the Name of Corficans! Let those who call themselves Genoese, or by any other foreign Name, be looked upon as unworthy Sons who deny their own Mother ! We cut them off from the Midft of us: We will have no Communication with them; and we lock upon them as cowardly Wretches, who have deviated from their Origin; we will pur fue them wherever we find them, until they return to their Duty, and join us to defend the common Heritage of our Fathers. The Valour of the Cor-

a few Times more, could speak any Word, Sent the Tyranny to which so many Attempts are made tence, or Discourse, with the Help of his Finger, to subject it. It is solely from their Courage that the Re establishment of Peace and Prosperity is to be expected: All these therefore, whom the vain Hope of feeing a Pacification has feduced, ought to rectify their Error, and at length acknowlege, that every Nation who takes Foreigners for Arbiters, takes the first Step towards Slavery, and does not deserve to enjoy the Condition of Free Men."

LONDON.

Sept. 26. The Three Sifters, Jenkins, who is arrived at Cork from Angola, fell in about fourteen Days before his Arrival, with the Pernambucco Fleet, homeward bound; and went on board the Admiral, where to his great Surprize, he found his own People, who fome Months ago had run away with his Boat upon the Coast of Africa, and afterwards took the Clayton, Capt. Patrick, belonging to Liverpool, and put the Captain in Irons. The Pyrates proceeded with the Clayton to the Coast of Brazill, and there fold the Slaves, but they were taken together with the Effects, by the Portugueze Admiral, who was bringing them Pri-foners to Lifbon, and had fecured the Ship and Effects for the Benefit of the Owners.

Copy of a Letter from Capt. M Namara, of the Friendship, arrived at Falmouth, from the Bay

of Honduras, dated September 22. happened in my Voyage to and from the Bay of Honduras, from whence I am now arriv'd in this Port, waiting for Orders where to proceed. In my Way to the Bay, on the 1st of May last, I called at the Musqueto Shore, in order to know how Matters were at the Bay, and immediately waited on Governor Pitt; who, to my Surprize, informed me that most of the Bay Men were there, being daily routed by the Spaniards. I faw like-wife on Shore nineteen Masters of Vessels, and eighty odd Seamen that had been taken by the Spaniards, and by them fet on Shore almost naked, and that there were about five Families left in the Bay. The Spaniards had Intelligence of my co-ming to supply the Bay Men with Provisions, and the Strength of my Ship, and of this being the third Voyage she made to the Bay ; which Information they had by fome Renegadoes that entered with them, of which there are a great many, inti-midated and forced by their ill Ulage, and encouraged by the great Shares they promise them out of the Prizes. They told me I should run a monflrous Risque in going to the Bay; but not know-ing where else to go, I resolved to run the Hazard, being encouraged by the Bay Men, who offered to go with me, and my Ship being able to sland a Brush, having twelve Six Pounders, and well provided with other Implements of Defence. Accordingly I took on board 40 Bay Men, and then mustered better than 70 able Men; however, notwithstanding I strove all I could to avoid meeting with the Cruizers, but to no Purpose; for about 7 Hours after I left the Shore, I met, off Rattan, a Galley hoisting Spanish Colours: She soon came up with me, and then we engaged one another very warmly, from Eleven in the Morning till after Three in the Afternoon. We received no other Damage than one Shot which hull'd us, the Sprit Sail Yards shot in several Places, and one Shot which took away the fore Part of my Shirt, and grazed across my Belly, and had I been more corpulent, should have had the Whole; but we fent the Spaniards away in a much worse Condition. One of her Conforts, during the Engagement, was diffant about fix Leagues, and by their Afliftance got her Leaks flopt; and being refitted, they joined and followed me again; but feeing two other Veffels of leffer Appearance, they made for them; by this Means I cleaped and got fafe into the Bay, where I was eleven Days before any of the Traders would come near me, fearing it was an Enemy; for just the Day before my Arrival, they had been visited by the Bracall Men, who made 19 of their ficans is alone fufficient to deliver the Nation from Negroes Prisoners, drove Mg. On ENVY and DETRACTION.

HOUGH all Sins have a Flavour of Pride, yet Detraction has a greater Dose of this bad Humour than ordinary. It is the chief Ingredient of this outrageous Crime; it discomposes the Stomach, and then immediately gives the Heartburning; and then the Tongue, which is it's Index, falls into Disorders. A Man, smitten with his own Excellencies, looks down from the Pinnacle of his foaring Conceit on other Mortals as Vaffals; he fancies Praise is an Inheritance entailed on his Merit; that either to respect or honour another, is to invade his Property, and to fet against him an usurping Competitor. Hence he runs in quest of a Foil, to make his own Perfections appear more gaudy, and sparkle with more eclat. Now what can give a more charming Turn to his suppofed Talent, than his Rival's Folly? Hence he rallies up in a Body all the Auxiliary Forces of Anger and Revenge; he takes the Field, and marauds upon his Fame; he dissects the poor 'Creature's Actions, and exposes the whole Anatomy of his private Transgressions to the View and Censure of the Public: For he wisely fancies, that the Fabric of his Vanity will fland unmoveable on the Ruins of a Rival's Reputation. Did the Breasts of the proud and haughty minded Men lie open to Sight; could we rifle all the abstrufe and dark Recesses of their Hearts, what Sallies of Joy should we discover at the most innocent Oversights of a Competitor? And then, whoever crows within at the Misfortune, will proclaim it at the first Occasion: For Joy, like Grief, is a stifling Humour, unless it throws off the Oppression.

If, therefore, you defire to speak ill of Nobody, think not too well of yourself; set not too exorbitant a Price on your Merits; remember you are no Phoenix, the only Individual of your Species; those Qualities you posses, are mere Gratuities, the Effects of God's Liberality, not of your De ferts; you had no Right to be, much less to be great, beautiful, or rich. Is it not Madnels, therefore, for you, who can lay Claim to nothing, to engross all the Gifts of Nature and Fortune ? Think not, God has exhausted his Treasury on you alone; he scatters his Favours where he pleases; and if he provides more plentifully for your Neighbour than for you, why do you complain? Must you be evil, because God is good? Must you cast a malicious Glance at another, because he has received some Marks of his great Maker's Kindness? Discompose not your Thoughts for other People's Advantages, but enjoy your own with Thankfulnefs. Fix just Bounds to your Defires, as well as to your Undertakings, otherwife you will rear up imaginary Callles of Greatness, to create to yourself a real

But, if you will contend for an honourable Poft, manage the Contest fairly; push on your Pretentions with Virtue and Generofity. Let Merit bear away the Prize, not Outrage; and, if your Rival carry off the Advantage, rather applaud the Conquest, than revise him. By lessening his Parts or Conduct, you bursesque your own; but then if you complain, and curse him in a Corner, you only betray your Impotence; Ill Nature, and Impiety. In fine, look at your own Failings and his through the same Glass, and you will see an humbling Spectacle; you will behold so many Objects worthy of Blame, that you will have no great Stomach to censure others.

Envy is the second Source of Detraction. This is an ill natured Vice, it loves Ill for Ill's Sake, and takes Pleasure in Torment; it is a Kind of Turnkey by Birth, and an Executioner by Profession; it seeds on Stench; and sucks Ratsbane from Balms; and Infection from Persumes; it not versions at good Turn; but when it designs an ill one; and setdom takes Things by the right Han-

dle; Mischief makes up it's Employment, Plagues and Famines are it's Diversion; it's Smiles are like Blazing Comets, which either hatch Treason, or portend it.

But, though any Mischief lies within the Reach of an envious Man's Wish, many are removed out of the Verge of his Power: Some move too high to be shot at, others too low; but neither Place norStation is a sufficient Fence against the Tongue. A Dwarf may engage with a Giant at this Weapon, or a Clown with a Lord. And for this Reaion, when the envious Man cannot come at his Antagonist's Person, he sets upon his good Name, and salls soul upon his Honour; and when, by the help of keen Satyr and false Glosses, he has beat down the Outworks that fenced his Fortune from Infult and Ruin, he draws his Cannon nearer, and raifes Batteries against his Grandeur and Estate that support it: For he knows that the best built Fortune cannot be stable, when Reputation, that propped it, is removed. Thus we see Socratus kept his Ground, and even triumphed over the Calumnies of his Accusers, whilst his Reputation interposed. But, when a buffooning Comedian drolled him into Contempt, he appeared no less guilty before the Judges, than despicable on the Stage. So that in Conclusion, Envy found him guilty, and the Senate pronounced the Sentence.

Methinks it is superfluous to dissuade a Man from this Vice. Interest is more powerful than Reason. We doat on Pleasure, and run from Pain by the Instinct of Nature. Who will not rather chuse a Prison with Satisfaction, than a Palace with Torment? But an envious Man, instead of following the Current of Nature, bears up against it. He labours for Labour's Sake, and drudges for the mere Expectation of Misery. He leads the Lise of Cain, haunted with the Spectres of his own Crimes from within, and with a thousand Jealousses from abroad; other Peoples Happiness creates his Torments; their Prosperity gnaws his Entrails; and his Impotence, to over cast the Sunshine of their Fortune, claps him on the Wheel. Now a Man that can fall in love with Pain, and court Disquiet, must not be cast in the same Mould that other Mortals are: And, therefore, I should think it as easy to dissuade People from Envy, as from

vaulting down a Precipice. But, besides, a Man that envies others, is always paid in the same Coin; his Honour will be as roughly handled; when one contests with Multitudes, he stands on the lower Ground, and fights at a Disadvantage. This is the envious Man's Case: For he cannot but know the disingenuous Descants on others Actions will reach the Ears of the offended Persons. Defaming Reports have a miraculous Sympathy with those, that Distance of Place is not able to dead the Echo; they rebound from Tongue to Tongue, are toffed from Hand to Hand, 'til they come to the Knowlege of the Injured; and, generally, like Snow balls, they increase in the Journey. What a grating Noise then will they make in the Ears of the defamed Person? Will not he think of Reprisals? Will he not treat your Honour with as little Regard as you have his? And God fend such an easy Satisfaction may affwage his Refentment. When Men fit Judges in their own Caufe, they make the Bills of Loffes and Damages rife high; who knows but they may demand Blood, and facrifice your Life to the Maner of their murdered Reputation?

In fine, remember you must die. When Death hath sealed your Eyes, you will find all the Darts of the Tongue shot at your Neighbour, stick in your own Soul; you will sel the Smart, but will find no Lenitive, no Cure: Why then shall we run headlong into those Crimes we must either devolve here, or suffer for hereaster? Let us look before us, and not, like Beasts, follow the mere Impressions of Passion. Let us shew we are Men, not by our Vices, but by our Virtues. To have Reason, and to act against it, is to debase our Species.

These Blessings if thou possesses, and wouldst preserve to Old Age; avoid the Allurements of Voluptuousness, and fly from her Temptations.

When the spreadeth her Delicacies on the Table, when her Wine sparkleth in the Cup, when the smileth upon thee, and persuadeth thee to be joyful and happy; then is the Hour of Danger, and let Reason stand firmly on her Guard: For, if thou hearkenest unto the Words of her Adversary, thou are deceived and betrayed.

The Joy which she promise the changeth to Madness, and her Enjoyments lead on to Diseases and Death.

Cast thine Eyes upon her Guests, who have listened to her Temprations. Are they not meagre f are they not fickly? are they not sprittes?

Their short Hours of Jolity are followed by tedious Days of Pain and Dejection: Her Votaties are become her Victims; the just and natural Confequence, which God hath ordained in the Constitution of Things, for the Punishment of those who abuse his Gifts.

CONSTANTINOPLE, September 20.

HIS unweildy despotic Empire seems to be at prefent the Seat of Confusion. The Sa crifices lately made, of the Grand Vizir, and the Chief Eunuch, whose Treasures are said to amount to 10,000,000 Sterling, have been follow'd by the Death of the Mufti. Yet all these Executions are looked upon as only Forerunners of the Deposition of the Grand Signior himfelf, unless he complies with the Spirit of the Janizaries, to commence a War with the Christians; to debate upon which, a grand Divan is to be affembled. By Letters dated August the 14th, from Smyrna, the Plague is faid to rage there with great Violence.

Ratiforn, Sept. 15. The Affair of an Election of a King of the Romans, which has been the principal Object of this Summer's Negotiation, is now very little talk'd of. The Court of Vienna is principally taken up with the important Advices from Confiantinople, uncertain over what Place the impending Storm will burft. It has also been making Provisions for the proper Qualifications of future Ministers of State, and for the Education of Youth in the martial Sciences. It has refused to

fatisfy the Pretentions of the Elector Palatine, as the Damages he received in the late War were the natural Confequences of his violating his Engagements to maintain the Pragmatic Sanction.

Madrid, Sept. 19. The Ministers of this Court being convinced of the ill Effects of the long Neg-lect of their Manufactures, and the immense Loss the Nation has fultained from the Ruin of 40,000 Looms, which formerly flourish'd in the Cities of Seville, Granada, and Toledo, which produced annually about 40 Millions of Crowns, have of late began to apply a Remedy. They have accordingly invited Workmen from all Nations, particularly England and Ireland, by offering great Encouragement; and after procuring from England Cards, Shears, Looms, and other Utenfils for the Woollen Manufacture, are now intent on the Manufacture of printed Linnens, lately fet up; and have prohibited the Importation of all foreign Manufactures of that Kind into the Port of Alicant. The King has establish'd a military School for the young Noblesse, and is improving his Marine; for this Purpose, Ship Carpenters of all Nations are invited into Spain. Many are arrived here from Genoa, and an Irishman of that Profession is engaged to build feveral large Ships at Cadiz. On the 22d of August, eighteen Tartans arrived from Naples at Cadiz, laden with Wood for building eight Ships of the Line, which are upon the Stocks there. Mean time the King's Generofity, or rather Profusion to his Family, will appear strange to an English Subject; an Instance of which is, his having made a Present of 400,000 Crowns to the Duchess of Parma, to defray the Charges of her Journey into France.

Paris, August 25. Ever fince the Assiento Contract between England and Spain has been abolished, the French Ships have taken the Negroes from the Coast of Guiney, and carried them into the Spanish Colonies. They carry on this Trade with the greatest Profit, as they at the same Time supply the French Colonies. There is come here from China, on board one of our Ships lately arrived at Port l'Orient, several young Chinese, who are fent into France to be educated, and who are afterwards to be employed in their Country as

Missionaries. LONDON.

Sept. 16. By a Letter from Woodbridge in Suffolk, we learn, that the Country People about Afpal Stonham, and the Neighbourhood, are still fo full of Ignorance and Superstition, that they ima gine there are several W ches and Wizards in the Neighbourhood; and that they have tied up two or three old People in Sheets, with Cords round their Middles, and flung them into the Rivers, to fee if they could fave themselves; but whether the Cords held them up, or Providence supported the poor Wretches, it's certain they got fafe on Shore. This has confirmed their Opinion; and to them they attribute the Lofs of Cattle, bad Harveft, &c. and infift that these poor Wretches shall be tried by the Church Bible, whether they are Witches or no; for if Witches the Bible will turn round, and not weigh them down, and fuch idle Stuff; but the Clergy in that Neighbourhood are too wife to liften to them, or suffer such nonsenfical Trials. Extract of a Letter from an elderly Gentlewoman

of great Reputation in the Town of Buckingbam, dated August 10, 1752, to an eminent Divine in London.

Dear Sir,

The Stile AA, as they call it, being to take Place the 3d of next Month, it gives me vast Concern to think that we must then give up that Sabbath which was appointed fo many Centuries ago to keep boly, by God and our Saviour. According to our present Method of Reckoning, the 30th of this present Month of August is Sunday; and, was not the eleven Days to be dropt, the following Sunday would have been September 6, the next September 13: Whereas now, according to this new Alteration, after Sun day August 30, we are to bave no more Sundays 'til September 17. Had no Sunday been kept from August 30'til September 20, it would bave given me no Manner of Uneafiness, as we should only bave dropt two Sundays, and then have kept our natural Sundays as before; but I am fadly at a Loss to conceive bow thinking People can reconcile it to their Consciences to go to Church on Thursday, September 17, and call it Sunday; and to open their Shops, and fet their People to work on Sunday, September and Jet their People to work on Sunday, September 20, and call it only Wednesday; for my Part, who am a strikt Observer of that Holy Sabhath, only appointed by God and my Sawiour, I cannot reconcile it to my Conscience at all; and therefore beg the Favour of you, Sir, as I know you to be a Man of great Learning, to clear this Matter up to me in a Post or two. [Surely this venerable Gentlewoman cannot be suspected of Witchcrast.]

September 17. By a Letter from Cockermouth. dated August 13, we learn, that on the 10th Inwas brought to Bed of two Sons and two Daughters, all alive, but three of them died foon after, and were buried in one Coffin. The People in the Neighbourhood have made a Collection for him, amounting to above twelve Pounds, which has put Knot into such high Spirits, that he is ready to venture a Wager that he produces the like again before the Year is out.

Sept. 26. A few Days fince the following Ac. cident happened to the Wife of one John Rogers, a Day Labourer, at Chesham, in Buckinghamshire, viz. The poor Woman had determined to make a whole Day a Nutting, and according provided a Bag, a Nut Hook, a Pennyworth of Gingerbread and a Dram, and fet out early in the Morning, on Friday, but did not return at Night. This greatly alarmed her Hufband, and he concluded fome Misfortune had happened to her. The next Day he went in order to find her out, but to no Purpole: for after the strictest Enquiry, he could hear nothing of her. On Sunday Evening he acquainted his Neighbours with it, and consulted with them what was best to be done; some of whom were of Opinion, that the might have fallen into a Chalk Pit, as there are feveral about the Woods; upon which he got three or four Boys who were acquainted with these Pits, by their playing, and Birds Nesling often that Way, to go along with them on the Monday, which they did, and in about three Hours they found her in the Bottom of one of those Pits, near 30 Yards deep, in the Hodge Wood. #### BOSTON.

November 20. Friday last, between 8 and 9 o'Clock in the Evening, as four Seamen were go. ing quietly along the Street towards the North End of the Town, they were met by a great Number of Boys and young Fellows, armed with Clubs, &c. who fell upon the innocent Men with great Violence, three of whom made their Escape, but the other, named John Crabb, was knock'd down, and beat in a terrible Manner: However, he made thift to crawl to an obscure Place, at some Distance, where he lay for an Hour or two, but being found, was carried to the Watch House, on the Dock, supposed to be in Drink. He seemed to be in great Pain, foam'd at the Mouth, and endeavoured to speak, but in vain, and died in a short Time. The next Day his Head was opened by a skilful Surgeon, who found his Skull fractured, and a large Quantity of coagulated and extravafated Blood between the Bone and the Skin, occasioned by fome violent Blows, which was judged to be the Cause of his Death; and it appearing to the Jury of Inquest, that the Deceased had received some Blows with a Club from one Chubb, a flurdy white Boy, and a Negro Fellow of the Gang, they were both committed to Goal.

Be always ready to comfort the Distressed of all Conditions. Do nothing but what is worthy of Praise, without aiming at Applanfe; the Oftentation of a good Action often ecliples the Glory, which it would otherwise de-

If you shall hereafter be bleffed with a good Husband, endeavour to make the Bleffing permanent by your Love, Virtue, and a generous Confidence. But, should your Lot be so unhappy as to have your Mind torn and distracted with the Agonies of domestic Jars, look out for Friends, who have a greater Regard for your Virtue than your Beauty; and, if by that Means you get no Relief, feek it from him who alone can extricate us out of the deepest Distress. Sloan informs us, that they have had abundance of Rain at Cape Fear, in the Months of September and October last, which occasioned such great Freshes as never were known there before; and which not only overflowed their common low Land, but much of their higher also, ruined all their Crops, and drowned and carried away much Cattle: That the Price of all Provisions was much rifen, Indian Corn being, when he left it, upwards of Four Shillings Sterling per Bulhel.

He also informs us, that about five Weeks ago, there was an Infurrection of the Negroes at Cape-Fear, which greatly alarmed the Imabitants; but by good Providence, they were happily quell'd before any great Damage was done.
PHILADELPHIA, November 30.

REASON, a Proof of the CHRISTIAN RELI-GION, and ferious Thoughts on LIFE and DEATH.

HE Life of Man, like the rifing Sun, fwiftly mounts to it's meridian Height; and then as rapidly runs on it's Decline again: As his Body is in perpetual Change, like the Graft, that by quick, though imperceptible Degrees, to it's Perfection grows, then withering, decays and dies; or as a Flower, that for a Moment blooms; then decoring fades away: 60, also are all the Please drooping, fades away; fo, also, are all the Plea-fures which Man's Body courts, equally mutable and transient. But Man's intellectual Part, being immortal, if he would be happy, he must fix his Happiness on something that is immortal also. Nor can any Thiog be more abfurd, than for an eternal immortal Being to fix it's Happiness on Things that are mutable and mortal.

This World, like a Man's Body, is mortal too, and must die, and pass away like a Dream; but the next World, like his Soul, will be eternal and immutable; and will, like Truth, for ever last.

It is therefore the Goodness of Gop that has

mingled fome Infelicity in every State and Condi-tion of this Life; has joined the Thorns of Pains and Care, to the Rofes of Health and Pleasure; that we might not fix our Hearts be this World, but look forward to that eternal Habitation, for

which this Life is only Preparatory.

As in the fall of Man there is certainly fome great Mystery: So there is also in his Make, a Ray of Immortality immersed in Matter, and cloathed in Clay; a Spirit that pre-existed it's pre-fent mortal Prilon, and will furely survive it's Dis-solution: Yet of the State of such Spiritual Pre-existence we have no Reminiscence; the Power of the Almighty has drawn over it the Curtain of Darkness and Oblivion; and all it's Traces being utterly obliterated, we retain only an earnest De-fire to know. Our Reason being thus limited, teaches us to wonder at and adore the Almighty Power of our Creator; and to have all his Works in the highest Admiration. As our Reason cannot foar so high as to know what even we ourselves are; how much less then can we be able to comprehend our Creator? Our Reason does, indeed, tell us it is impossible; it teaches us to rest ourselves on higher Knowlege, and to rely upon Sacred Scripture, and Divine Revelation. In this also, our Reason must be our Guide, to judge whether fuch Revelation be divine or not. But when our Resson has such Proof as to be sufficiently convinced of it's Divinity; we furely ought to believe all that is therein contained, though it should ever so much exceed our Capacity of Comprehension, efpecially when relating to the Nature of the Deity; becaule the Being Incomprehensible is one certain Attribute of an Infinite Creator: Nor can any Definition of God be true, that his Creatures can comprehend. But some Men's Minds are so feed. comprehend. But fome Men's Minds are fo fcap tical, that they will not give themselves Time, fairly and impartially, to examine the Evidence, and peruse the Proofs. If Men would but cooly and candidly consider the Contents of the Christian Religious Religion, they would farely find every possible De-monstration of it's Divibity. If an Attonement, which could only be adequate to, and fufficient for the Size of the Country of the Size of the Siz the Sins of the whole World; an Oblation, such as no human Creature could ever have invented, and never could have entered into the Heart of Man to imagine: If a long Train of Prophecias fulfilled, and a Multitude of other Miracles performed, all attested by such Evidences as admit no Probability of Imposture, nor even Possibility of Deceit; unless Pains and Poverty. Torments and Death, can be supposed to be sufficient Inducements to deteive; if such facred and sublime Laws as can only make Mankind happy bere, and hap pler hereaster, are, when together all united, sufie Sins of the whole World; an Oblation, fuch

ficient Evidence to fatisfy our Reason, and create Belief; they do all undoubtedly meet in, and incontestably prove the Divinity of the Christian

As it is very wrong to be so Sceptically inclined, and doubtful in believing upon strong and convincing Evidence; so it is also to believe without examining at all, or being able to give any Reafons for our Faith,

Too many, it is to be feared, who call them felves Christians, receive their Religion only because it is the Custom of the Country, and the Fashion of the Place they live in; who, had they been born in Turkey, might have made full as good Mabometans; and are Christians not by Choice, but by Chance; not by Reason, but by Form and Name slave.

Christianity is certainly the Religion of right Reason; the facred Doctrine of the Deity himself; Gon's holy Word, and everlasting Truth. It inffructs us rightly how to adore our Creator, and love our Fellow Creatures, and always to hearken to, and obey, the unerring Monitor of our Minds: It contains not only every frecept to raife and ele-vate human Nature to Perfection, but an Attonement and Propitiation for all their Sins and unavoidable Imperfections; the more it is confidered, the more it convinces; and Time itself, the Touch-flone of Truth, and Detector of Falshood, confirms

it's Verity, and proclaims it's Power.
Religion, doubtlefs, is the firmest Foundation of Honour and true Happiness in every State and Nation, and the most permanent Pillar, and strong est Support, in every Kind or Form of Government. Review the Histories of all Ages past, both Sacred and Profane, and you will surely find, that every State or Country flourished or decayed, were happy or miferable, according as they were more or less Religious; and the Reason for it is very plain and just: Because Individuals may, and cer tainly will be, punished or rewarded, according to their Actions, in another Life; but public States and Communities, as fuch, cas only be rewarded or punished in this World: And, therefore, Na-tional Wickedness must ever expect public and national Punishments.

It is therefore the indifpensable Duty of all Rulers and Governors to deprefs Vice, and encourage Virtue; not only by the Power of their Places, but by the Examples of their Persons; for great Examples will perfusee and draw, where Power and Precept cannot prevail: Nor can the brightest Doctrine of the most pious Prelates, not even great Sherlock's facred Admonitions, have their due In fluence and proper Efficacy, unless those in high Rank and Place will inforce them by the All-perfuafive Power of their Examples. In vain may Jabnjon, fweetly rambling, paint all the Beauties of Morality, in their perfect Colours, if no illustrious Models of Moral Virtue will fland forth for public Patterns, and general Imitation. The in-ferior Classes of the People, which are by much the Major Part of Mankind, are ever ready, whether right or wrong, to follow and copy after the Modes of their Superiors; and the Vulgar might eafily be made virtuous, only by the mere Force

As the Thrones of Kings can be established only by Righteousness, how careful ought all Monarcha to be to sow amongst their Subjects the Seeds of found Morality, and to cause Platy, and true Religion, to be preferred, honoured, and revered; fince they may as well expect, that a Flower shall never fade, the Sun never set, nor Man's Body never moulder into Dust, as that Crown, or Kingdom, to continue and endure, where Lewdness and Immorality, Luxury and Corruption, Profanencies and Irreligion, live, sourish, and are promoted.

Sept. 30. By the last Advices from Constanti-nople, we are informed, that the Conduct of the new Grand Vizir is quite opposite to that of his Predecessor; and, either through Policy, or from his natural Inclination, he appears outwardly per-factly conformable to the Sentiments of the Janiza-ries. He advices War, not merely with a View to keep them employed; but upon a Principle of Neceffity, in order to preferve that martial Spirit in the Nation, which might be enervated by a longer Peace. Upon this Pretence, he had engaged the Grand Seignior to affemble an extraordinary Divan, to decide this important Queltion. Nevertheless. as feveral Bashaws of distant Provinces are to affift at this Divan; and as it will take up a great deal of Time for them to repair to Conflantinople, it is sufpected that this is an Artifice of the New Grand Vizir's to pacify this present Rage of the Janizaries, in order afterwards to make it appear doubtful what Step he intends to take. People are the more apt to look upon this to be the Case; because the Kan of the Tartars had not been invited to this Divas, as is usual when the Ports is voing to declare War.

REASON, a Proof of the CHRISTIAN RELI-GION, and ferious Thoughts on LIFE and DEATH.

Node dieque fuum gestare in pedore testem. Juv.

HE Life of Man, like the rifing Sun, fwiftly mounts to it's meridian Height; and then as rapidly runs on it's Decline again: As his Body is in perpetual Change, like the Grafs, that by quick, though imperceptible Degrees, to it's Perfection grows, then withering, decays and dies; or as a Flower, that for a Moment blooms; then drooping, fades away; fo, also, are all the Pleasures which Man's Body courts, equally mutable and transient. But Man's intellectual Part, being immortal, if he would be happy, he must fix his Happiness on something that is immortal also. Nor can any Thing be more absurd, than for an eternal immortal Being to fix it's Happiness on Things that are mutable and mortal.

This World, like a Man's Body, is mortal too, and must die, and pass away like a Dream; but the next World, like his Soul, will be eternal and immutable; and will, like Truth, for ever last.

It is therefore the Goodness of God that has mingled some Infelicity in every State and Condition of this Life; has joined the Thorns of Pains and Care, to the Roses of Health and Pleasure; that we might not fix our Hearts on this World, but look forward to that eternal Habitation, for which this Life is only Preparatory.

As in the fall of Man there is certainly some great Myttery : So there is also in his Make, a Ray of Immortality immerfed in Matter, and cloathed in Clay; a Spirit that pre-existed it's prefent mortal Prison, and will furely furvive it's Difsolution: Yet of the State of such Spiritual Preexistence we have no Reminiscence; the Power of the Almighty has drawn over it the Curtain of Darkness and Oblivion; and all it's Traces being utterly obliterated, we retain only an earnest Dehire to know. Our Reason being thus limited, teaches us to wonder at and adore the Almighty Power of our Creator; and to have all his Works in the highest Admiration. As our Reason cannot foar fo high as to know what even we ourselves are; how much less then can we be able to comprehend our Creator? Our Reason does, indeed, tell us it is impossible; it teaches us to rest ourselves on higher Knowlege, and to rely upon Sacred Scripture, and Div.ne Revelation. In this also, our Reason must be our Guide, to judge whether such Revelation be divine or nor. But when our Reason has such Proof as to be sufficiently convinced of it's Divinity; we furely ought to believe all that is therein contained, though it should ever so much exceed our Capacity of Comprehension, es pecially when relating to the Nature of the Deity; because the Being Incomprehensible is one certain Attribute of an Infinite Creator: Nor can any Definition of God be true, that his Creatures can comprehend. But some Men's Minds are so scep tical, that they will not give themselves Time, fairly and impartially, to examine the Evidence, and peruse the Proofs. If Men would but cooly and candidly confider the Contents of the Christian Religion, they would furely find every possible Demonitration of it's Divinity. If an Attonement, which could only be adequate to, and fufficient for the Sins of the whole World; an Oblation, fuch as no human Creature could ever have invented, and never could have entered into the Heart of Man to imagine: If a long Train of Prophecies fulfilled, and a Multitude of other Miracles performed, all attested by such Evidences as admit no Probability of Impolture, nor even Possibility of Deceit; unless Pains and Poverty; Torments and Death, can be supposed to be sufficient Inducements to deceive; if such facred and sublime Laws as can only make Mankind happy here, and hap pier hereaster, are, when together all united, suf-

ficient Evidence to fatisfy our Reason, and create Belief; they do all undcubtedly meet in, and incontestably prove the Divinity of the Christian Religion.

As it is very wrong to be so Sceptically inclined, and doubtful in believing upon strong and convincing Evidence; so it is also to believe without examining at all, or being able to give any Rea sons for our Faith.

Too many, it is to be feared, who call them felves Christians, receive their Religion only because it is the Custom of the Country, and the Fashion of the Place they live in; who, had they been born in Turkey, might have made full as good Mahometans; and are Christians not by Choice, but by Chance; not by Reason, but by Form and Name alone.

Christianity is certainly the Religion of right Reason; the facred Doctrine of the Deity himself; God's hely Word, and everlasting Truth. It instructs us rightly how to adore our Creator, and love our Fellow Creatures, and always to hearken to, and obey, the unerring Monitor of our Minds: It contains not only every Frecept to raise and elevate human Nature to Persection, but an Attonement and Propitiation for all their Sins and unavoidable Impersections; the more it is considered, the more it convinces; and Time itself, the Touchstone of Truth, and Detector of Falshood, confirms it's Verity, and proclaims it's Power.

Religion, doubtless, is the firmest Foundation of Honour and true Happiness in every State and Nation, and the most permanent Pillar, and strong est Support, in every Kind or Form of Govern Review the Histories of all Ages past, both Sacred and Profane, and you will furely find, that every State or Country flourished or decayed, were happy or miserable, according as they were more or less Religious; and the Reason for it is very plain and just : Because Individuals may, and cer tainly will be, punished or rewarded, according to their Actions, in another Life; but public States and Communities, as fuch, can only be rewarded or punished in this World: And, therefore, National Wickedness must ever expect public and national Punishments.

It is therefore the indispensable Duty of all Rulers and Governors to depress Vice, and encourage Virtue; not only by the Power of their Places, but by the Examples of their Persons; for great Examples will persuade and draw, where Power and Precept cannot prevail: Nor can the brightest Doctrine of the most pious Prelates, not even great Sherlock's facred Admonitions, have their due In fluence and proper Efficacy, unless those in high Rank and Place will inforce them by the All perfuafive Power of their Examples. In vain may Johnson, sweetly rambling, paint all the Beauties of Morality, in their perfect Colours, if no illustrious Models of Moral Virtue will fland forth for public Patterns, and general Imitation. The in-ferior Classes of the People, which are by much the Major Part of Mankind, are ever ready, whether right or wrong, to follow and copy after the Modes of their Superiors; and the Vulgar might eafily be made virtuous, only by the mere Force

As the Thrones of Kings can be established only by Righteousness, how careful ought all Monarchs to be to sow amongst their Subjects the Seeds of found Morality, and to cause Plety, and true Religion, to be preferred, honoured, and revered; since they may as well expect, that a Flower shall never fade, the Sun never set, nor Man's Body never moulder into Dust, as that Grown, or Kingdom, to continue and endure, where Lewdness and Immorality, Luxury and Corruption, Profanencies and Irreligion, live, sourish, and are pro-

LONDON, September 1.

AS held on board the Devonshire, at Chatham, a Court-Martial, Admiral Towns-

hend Prefident, upon a Charge exhibited by Vice Admiral Griffin, against the Hon. Capt. Powlet; when no Person appearing in Support of it, the Court esteemed it Groundless, and acquitted him.

Sept. 16. In the next Daily Advertiser, of the 18th, 45 Females puplished their Qualifications; and, in the same Paper of the 19th and 20th, 18 more Advertisements appeared to the fame Purport, from Women of various Ages, Maids, Wives, and Widows, to the no small Amusement of the Town.

Sept. 20. By Letters from Fort St. David's, dated Feb. 27, and brought by the Warwick Indiaman, there is Advice, that Capt. Clive had obliged the French and their Allies to retire from before Arcott, killed a great Number of Men, and put the rest to flight. That the English under Jingon had drove the French from before Trichenapali. That two Nabobs in the French Interest had come over to the English with a great Number of Men, and that the French in their return were furrounded, and were in great Diffress for want of Provisions. These Letters add, that M. Dupleix had sent Proposals to the English for an Accommodation, in the Preamble of which he fet forth, that he had only fuccoured the Indians that fued him for Affistance, and hoped that every Thing would be settled to the mutual Satisfaction and Advantage of the two Companies, and that all Animofities and Hostilities would cease.

Sept. 30. By the last Advices from Constantinople, we are informed, that the Conduct of the new Grand Vizir is quite opposite to that of his Predecessor; and, either through Policy, or from his natural Inclination, he appears outwardly perfeetly conformable to the Sentiments of the Janizaries. He advises War, not merely with a View to keep them employed; but upon a Principle of Necessity, in order to preserve that marrial Spirit in the Nation, which might be enervated by a longer Peace. Upon this Pretence, he had engaged the Grand Seignior to affemble an extraordinary Divan, to decide this important Question. Nevertheles, as feveral Bashaws of distant Provinces are to affift at this Divan; and as it will take up a great deal of Time for them to repair to Constantinople, it is suspected that this is an Artifice of the New Grand Vizir's to pacify this present Rage of the Janizaries, in order afterwards to make it appear doubtful what Step he intends to take. People are the more apt to look upon this to be the Case; because the Kan of the Tartars had not been invited to this Divan, as is usual when the Porte is going to declare War.

The Differences between the Court of Spain and that of England, are upon the Point of being accommodated by a new Convention, which is negotiating both there and at London, by the Ministers of the respective Courts. The Chevalier d'Abreu, who resides at the Court of Great Britain, has agreed with the Ministry there about the principal Points in Dispute; and Mr. Keene, his Britannic Majesty's Minister at the Spanish Court, has been at the same Time employed in removing some Difficulties there. The Plan of Convention is already drawn, which settles the Articles of Navigation and Commerce; and there is Reason to presume, that this great Affair will be completed after the Return of the King of Great Britain from his German Dominions.
