Frostburg State College Delegation Propose Resolutions

The Frostburg State College delegation to the Maryland Federation of College Republicans proposed the following resolutions. These resolutions received the unanimous approval of the MFCR, which represents sixty percent of all schools in Maryland.

Resolution 1: MFCR condemns the gross underfunding of State Colleges and Universities in Maryland and calls for higher priorities for education expenditures.

Resolution 2: MFCR joins the Maryland Council of Higher Education in calling for a "critical reenumeration" of the state's funding policy for higher education.

Resolution 3: MFCR supports Maryland State Senate Bill 406 as a means of insuring reasonable and responsible allocations for higher education in the state of Maryland.

Resolution 4: MFCR supports Maryland State Senate Bill 558, which al-

lows for tax deduction on state income taxes for the payment of mandatory fees and tuition.

Resolution 5: MFCR supports federal legislation calling for tax deductions on federal income taxes for the payment of mandatory fees and tuition.

Resolution 6: MFCR opposes President Carter's proposals to help meet the costs of a college education through increased federal bureaucratic control and increased spending for new programs of aid; allowing tax deductions accomplishes the same thing at considerable savings to the taxpayer in terms of money, time, and convenience.

Presentation to the Maryland State Senate on behalf of the Frostburg State College Student Association encouraging the passage of Senator Robert E. Stroble's Senate Bill 558 by John R. Isaac, the Director of State Affairs of the Frostburg State College Student Association

and David Johnson, the President of the same organization, to the Senate Budget and Taxation Committee.

Rather than deal with fiscal facts of which you are all familiar, I, on behalf of the Student Association of Frostburg State College and the Maryland Federation of College Republicans, would like to approach the importance of Senate Bill 558 by dealing with the concept and value of higher education itself.

Firstly, we view higher education as one the integral parts to the foundation of our highly technological society. We believe that education is a key factor in our democratic system and an enlightened citizenry is a cornerstone of democracy. (Thomas Jefferson) We feel that our governmental system is bettered by a higher average educational level over the poorly educated. This statement is justified by the common political science

fact that the higher an education one has, the more likely one is to vote and participate in our governmental process for its betterment.

The difficulty of paying for any educational expense in our always increasingly inflationary economy is becoming greater and greater. A tax deduction on higher education expenses would further educational opportunities for all families with students, especially our middle income families who bear the greatest proportional tax burden.

If Senate Bill 558's specific expense deduction creates a greater educational opportunity, then the enrollments of our higher education institutions will increase and create a much needed greater total revenue. I might point out that the state college's and universities' funding problems would be proportionately eased. This would be extremely likely when most of them claim en-

rollments are down too far.

Tax deductions are fine and good as long as they are specific enough for easy determination of what is and what isn't deductible. This bill specifically calls for a specific deductions of mandatory fees and tuition. This is easily seen for each individual by the student's bill as it is itemized. The simplicity and specificity of this bill's provision will ease the administrative function and oversight of this deduction.

Therefore, for all the previous reasons, I can safely assume that this bill is in the best interest of the citizens of Maryland and America. I'm confident of the backing of families with members of in higher education around the state, and I have the endorsement of the Frostburg State College Student Association and the Maryland Federation of College Republicans specifically for Senate Bill 558's passage by this committee and the General Assembly of this fine state.

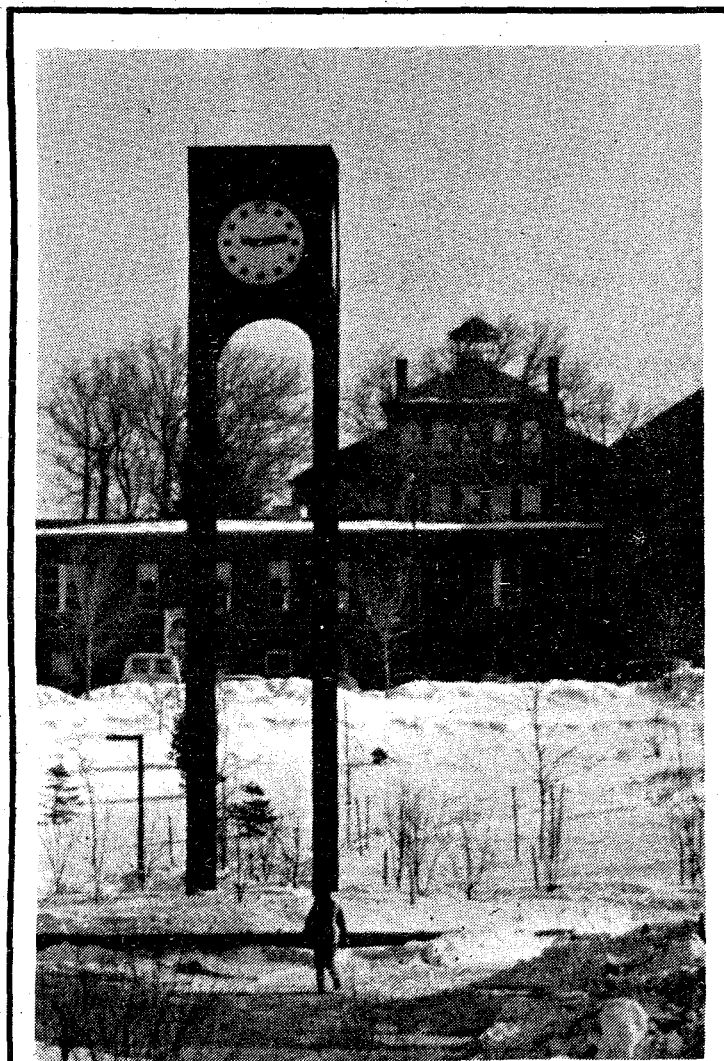
Students in Secondary Teacher education who plan to enter a teaching internship for the second semester of the academic year 1978-1979, please note the following procedures:

Dear Acting Governor Blair Lee, III:

We, the brothers of Tau Kappa Epsilon Fraternity of Frostburg State College are writing to express our concern about the lack of financial support for higher education institutions in the

state and at Frostburg State College.

According to records published, funds should be distributed equitably among the institutions of higher learning in Maryland, according to staff reports of the Maryland General Assembly. The report recommends that the state's present system of funding be stopped. As students of Frostburg State College we feel it is your duty as Governor to explain why the University of Maryland receives 59.0% of state money and only 31.3% of state moneys goes to state colleges. According to the report, an equitable distribution of state money would subtract over eight million dollars from the University of Maryland's budget.

Frostburg State College which is located in a cold, snowy, and windy Western Maryland, is budgeted for next year \$22,000 less than the amount appropriated for this year. It appears that State control of these institutions' budgets, through the Department of Budget and Fiscal Planning is excessive and in the hands of people who lack accountability for deciding educational priorities.

We feel that the decrease in the budget for Frostburg State College will put a burden on the students. The students who have watched President Nelson Guild try to get more funding, but turned away, the students who saw J. Carson Dowell, Chairman of the Board of Trustees resign because of a protest against the inadequate and unresponsive state funding of four-year public institutions, the students who have watched the physical education building, the library, the Lane Center, and many other buildings on campus have their hours cut to an almost nothing, the students who have seen the energy crisis take away many of the activities on campus, the students who have been caught in the middle of a situation which only you can solve. Therefore we ask you just how much more can these students sit back and watch?, are they going to sit and do nothing? Our answer to this is NO! The students have taken all they are going to. The once cheerful campus at Frostburg State is no more. As a fraternity on campus we have suffered through the budget crisis with much sadness. Our social activities have been cut greatly because of the Lane College Center hours and our meetings have been cut because there is a lack of meeting places due to the shut-down of many buildings on campus.

Therefore Governor Lee, we are asking that you take into consideration the

requests of our President, Nelson Guild, and end this heavy burden which has struck our campus. We are counting on your support to put Frostburg State College into a cheerful spirit again. We would very much appreciate a reply from you.

Music Fraternities "Worms and Maggots"

All things appear to be running smoothly at FSC's Music Department. One need only to walk the halls of the Fine Arts building to notice students practicing and professors preparing lectures. But why are so many students rehearsing around the first floor drinking fountain? They aren't rehearsing; the chorus of "yes sirs," "good morning sirs," and the "Worm Song" are part of pledging. These "pledges" dress in coats and ties ("Maggots") and keep strict records of the degradations they must undergo to become members of Phi Mu Alpha Sinfonia (P.M.A.S.) or Delta Omicron (D.O.) These "Professional Organizations" are for the express purpose of furthering the cause of music at F.S.C. However the members of these two organizations should scrutinize closely the total effect they have upon the Music Department for their goals are accomplished at a cost they misapprehend.

Members of P.M.A.S. and D.O. will carefully elaborate upon the concerts they perform, the various scholarships they award, and the services they provide music majors. I agree: the ear-training clinics, recitals, and scholarships are beneficial. P.M.A.S. and D.O. also provide ushers and stage hands for most recitals and concerts at F.S.C.

These services are invaluable, unfortunately they are counterbalanced by equal disservices, including discrimination against women. D.O.'s grade requirements are higher than P.M.A.S.'s which perhaps encourages greater scholarship. Yet the overall effect precludes any woman with respectable grades (2.0 to 3.0 G.P.A. in music) from joining a music service organization. A man with the same grades may join P.M.A.S.

Furthermore, P.M.A.S. and S.O. contribute to factionalism in the Music Department. Last semester, for example, D.O. held a "Meanest Professor" contest. Anyone could vote by putting money into tin cans which represented each professor in the Music Department. The professor who collected the most money is his or her name was the meanest. This was supposed to be done in a spirit of good fun, but nobody considered the subtle implications of such good fun. In advertisements students were urged

to participate because this was their opportunity to get even. Students donated money with vengence, not humor. A contest for the best professor would have been more in line with furthering the cause of music, and less in furthering the tensions in the department.

More factionalism is created by the inherent feelings of being "in" or "out" of organizations such as P.M.A.S. and D.O. This alienation is worsened by rumors that P.M.A.S. has copies of previous tests on file for members to consult.

Finally, to join these organizations, one must submit to the delights of hazing. Ostensibly this tradition creates a close-knit, hardworking, responsible organization. I have never understood how the insane and destructive rituals P.M.A.S. and D.O. enjoy will make one responsible to an organization or cause. On the contrary, it may have the opposite effect. Hazing seems to inhibit rather than enhance their organizations. Indeed, knowing many members, I feel P.M.A.S. and D.O. as organizations, are less than the sum of their personnel's ability. It doesn't make sense that groups, whose stated goals are the advancement of music (and hence the humanities), would revel in such unhumanitarian conduct as hazing. Hazing is contrived, true brotherhood is not.

The Brothers of P.M.A.S. have chosen to continue hazing despite the efforts of their national organization. In the November issue of the "Sinfonian" (P.M.A.S.'s national newsletter) Robert Etheridge, Vice President of Student Affairs, Miami University writes that fraternities should dispense with hazing and continues "why not try a return to 'civility,' the 'behavior proper to the intercourse of civilized people'?" The editors of "Sinfonian" felt this editorial sufficiently important to print, but the hazing at F.S.C. continues.

As for tradition, any tradition which hurts someone physically, mentally, or symbolically should not be maintained. Tradition seems important to P.M.A.S. and D.O., unfortunately the Greek traditions they keep are more Spartan than Athenian.

The Brothers of Phi Mu Alpha Sinfonia and Sisters of Delta Omicron should weigh the positive and negative characteristics of their organizations. Several alternatives are possible. They could change their goals to honest hedonism and declare themselves social clubs. More positive would be a change in their behavior (particularly regarding hazing) that more appropriately reflects their dignified aims. At any rate, a general rethinking is needed to fulfill their potential. There is a desperate need for more (and more effective) support of the arts. Either choice is better than the current situation.

Garrett A. Morgan

Who was Garrett A. Morgan? Yes it is true that he is an Alpha. But what did he do? He was an inventor -- an inventor whose inventions are familiar to all of us, but his achievements are among the many accomplishments of Black Americans that have been systematically purged from the history books for years.

If you listened closely to the Stevie Wonder song, "Black Man," you may have heard his name mentioned for one of his most famous inventions -- the gas mask. The value of Morgan's "breathing machine" was first acknowledged during a successful rescue operation made necessary by a tunnel explosion which found several men trapped in the Cleveland Waterworks some 200 feet below the surface of Lake Erie. During the emergency, Morgan, his brother and two volunteers -- all wearing "breathing machines" -- were the only men able to descend into the smoke and gas-filled tunnel and save the lives of the trapped men. Needless to say, orders for Morgan's invention poured into Cleveland from fire departments all over the country. However, when Morgan's race became known, many of those orders were cancelled. Nevertheless, the United States Army did order Morgan's "breathing machine" and adopted for use in WWII.

One of Morgan's other inventions is so common but so useful, you probably would never guess what it is. You see it every time you drive down a city street. Yes, it is true, Garrett A. Morgan, a Black man, invented the multi-color traffic signal -- the stop light. Wake everybody.

Chairman of the Business and Economics Department spent the preceding three months planning the program with Mr. Ernest Spriggs, Vice-President of Finance and Larry Swanson Manager of General Accounting. The morning program involved small group visitations to eight departments: data processing, corporate factory accounting, general accounting, budgets & forecasts, marketing and customer accounting, tax, Cumberland plant accounting, and credit. Following lunch, a general presentation by members of the marketing and manufacturing divisions was given. The day was concluded by comments and discussion between the members of the executive finance staff and the students.

Through cooperative efforts of the Kelly-Springfield personnel and the College staff, this program, the first of its kind, proved to be a comprehensive introduction to the corporate finance and industrial accounting division of a large manufacturing company. Plans to have such an event continue on a semester basis will be pursued.
