Faculty Senate Meeting scheduled for October 20 during advising week is cancelled

New Business

Report on the Status of General Education Review presented by Dr. James King, Co-Chair of the General Education Steering Committee (see documents)

General Education Review Survey

- Faculty will receive one more reminder of the faculty survey about General Education; there have been 315 responses so far
- Survey will close on October 19
- Survey working group is in the process of analyzing the data and preparing a summary
- A student survey is underway and is available to students in MyClasses
- An alumni survey was also distributed; that data is also currently being analyzed

Open Sessions

- Open Sessions were held on October 6, 7 and 8 to explore options at how General Education curriculum can be enhanced
 - Very low attendance but good input from those who did attend

- Faculty Senate President suggested that attendance may be low since there is no specific proposal that is being considered; Steering Committee may want to consider meeting with academic departments as an alternative way of collecting feedback rather than relying on open meetings
- Feedback that was obtained via the open sessions included:
 - Concerns about our current General Education program
 - Suggestions for how the General Education program might be changed
 - Developing an app to provide descriptive material of General Education courses; perhaps even a brief video by the faculty member describing their GenEd course
 - Having a "speed-dating"-like advising forum where students can go table-to-table and briefly meet with GenEd faculty and learn of the various GenEd course offerings
 - Discussions on the use of a "thematic approach" to General Education
 - Discussions on General Education models at peer and aspirational peer institutions and the model currently in use at College Park (because that institution revised its program quite recently)
 - Some peer institutions with thematic approaches to General education:
 - Appalachian State University
 - Bloomsburg University
 - Dartmouth College
 - Millersville University
 - Portland State University
 - University of Massachusetts
 - University of North Carolina Wilmington

Discussion on General Education Review and Open Sessions feedback

- We should change student perceptions regarding General Education: Students, and perhaps some faculty during the advising process, seem to think of General Education as something to "get out of the way"
- Is there value in a "sequential approach" to General Education to allow for upper level courses to be categorized as GenEd courses and which would require prerequisites

- Use of Advanced Placement (AP) Courses/Tests: Many expressed concern at granting college credit if a student gets a score of '3' on an AP exam; Perhaps '4' should be the minimum expectation
 - One Senator commented that that it was common for students to earn a '5' on the AP calculus exam, so perhaps the AP exams themselves are not wholly reliable
- Limit the number of GenEd courses that can be satisfied with an AP exam
- Change the name of the program; "General Education" is not particularly informative or enticing
- Use language makes sense to students and parents; 'Group IIIA' (for example) doesn't make sense to anyone
- We should encourage breadth in modes of inquiry as we consider the elements of a good general education program

— ENGL 103

- Because of articulation agreements, many students get credit for ENGL 103 but have not taken it at SU
- There is a perception that transfer students who do not take the course here are less prepared for writing in their other classes
- One suggestion is to require students to satisfy two requirements: composition and information literacy; In this case, the transferred ENGL class would satisfy the composition requirement but perhaps not the literacy requirement
- We need to communicate to parents that we are not here only for the purpose of career preparation
- As part of the advising process we need to help change student mindset that "getting a convenient schedule" is a priority
- Pre-loading students into courses
 - Perhaps students are prohibited from choosing GenEd courses that are more appealing to them and are scheduled at the same time as the course in which they are preloaded
 - How can we inspire students when they don't even know what they are taking

- We might consider distributing advising loads more broadly and across disciplines; Faculty in smaller departments could perhaps advise students from other disciplines and thus potentially expose students to courses outside their major
- Should we be comfortable with online courses taken at community college transferring here as general education courses
- Related to discussions of a "thematic approach" we should aim to "carefully tweak" our curriculum instead of chasing fads
- We do seem to plan general education course offerings as effectively as we plan our major course offerings
- Let us not lose site that the "general" in General Education is derived from "genre" not "generic"
- While we may end up proposing a new general education program, the status quo should be on the table as well when it is time to vote
- Improving faculty feedback regarding General Education Review
 - We might consider doing holding open sessions during the week before classes begin in the spring semester; and we should schedule and publicize it now
 - Perhaps the Provost would be willing to sponsor a wine and cheese reception as part
 of this event; Suggestion to consider an open meeting in the evening or on a
 weekend
