As per our discussion on Friday, I am approving the Faculty Senate recommendation to move the due date of faculty annual evaluations by chairs from February 1 to March 15. This will take effect starting with the 2007 calendar year and I am authorizing the existing deadline for the calendar year 2006 to be pushed back From February 1, 2007 to March 15, 2007. However, the annual evaluation on faculty up for promotion should be completed earlier than March 15 so that it can be included in their promotion package.

Also, the Faculty Senate included as part of there recommendation to me that the Faculty Welfare Committee would develop a formal process designed to provide feedback to tenure-track faculty with contract renewal deadlines that occur before March 15. Until the Faculty Welfare Committee has time to deliberate on this issue, I am asking that chairs keep their non-tenured tenure-track faculty appropriately informed in a timely fashion on their performance so that, if necessary and possible, corrective action can be taken prior to contract renewal notification deadlines (first year = March 1; second year = December 15; third year = August 1).
