SU Faculty Senate Presidents Plaque

Motion presented by Dr. Chrys Egan: In honor of the 20th year of the Salisbury University Faculty Senate, I move that we establish a plaque in commemoration of Faculty Senate Presidents to be displayed in the Guerrieri Academic Commons Faculty Center (AC 230).

Justifications:

1. Faculty Senate began in the academic year 1997-1998. The academic year 2017-2018 commemorates 20 years of shared governance between faculty and administration.
2. The plaque would serve as a historical marker of the Faculty Senate and of the faculty members who served in the highest leadership position.
3. The placement of the plaque in the Guerrieri Academic Commons Faculty Center is fitting since that designated faculty space has two other faculty commemorative plaques, The Distinguished Faculty Award and The Faculty Memorial Scholarships.
4. Voting to support the plaque now is appropriate for several reasons; in honor of the first Faculty Senate President, David Parker, who currently serves as a Senator; in recognition of the current President Stephen Ford, who has served this year as the first 'caretaker' of the new Faculty Center; to acknowledge current Senators David Rieck and Darrell Mullins, who have each served two terms as President; and to honor all past Presidents.
5. Provost Diane Allen, who has worked with the Faculty Senate for eight years, retires this June 2017 and has authorized the plaque. Dr. Egan will work with Kim Meyer in the Provost's Office to have the plaque in place for the 2017-2018 academic term.
