## DEVIL PUTS A BOY ON HOT GRIDIRON

Naughty Lad Disobeys His Mother and Gets Into Many Kinds of Trouble.

### STEPS ON THIRD RAIL

Said Afterward That He Thought He "Blow Up," and That His Back and Legs Felt Like Something Was Going Through Them.

New York.—A very persistent devil whirled into the ear of nine-year-old Charles Moffat as he left his home at No. 85 Catherine street to play in the street the other afternoon. "Remember," his mother had said, "the devil gets boys who are bad. You mustn't go out of the neighborhood and you mustn't get papers for the newsmen."

For Charles's principal income and ready fund came from the money the newsmen on the corner gave him for trips to a news company.

Though Charles had promised neither to leave the street nor go for papers, the devil suggested that the day was Saturday and that the boy wouldn't be paid for his week's work unless he finished it, and that it would be too bad to lose a whole week's pay just because of failure to work one day.

Charles, tempted, fell. He trotted quickly to a news depot in Chambers street and started to go home. But that devil whispered again. It would be nice to go out on Brooklyn bridge and see how the motormen ran their trains to Coney Island. Again Charles fell. He got by the policemen on the northern vehicle roadway of the bridge, and with his package of "55 cents' worth of papers" stood close to the Manhattan bound track of the "L" train.

A train went by. The devil jogged Charles's arm and the package fell to the tracks a few feet below. The small transgressor decided he would have to rescue the papers or he wouldn't get his pay.

"I hung on wid me hands," said Charles afterward, "and then I put

"Me back and me legs felt like something was going through 'em," says Charles. He went into the air, shrieking with pain. But he only rode two feet; then he came down sitting between the rails. A moment afterward he was standing up in the center of the track, rubbing himself, while a crowd of homeward bound Brooklynites was standing on the promenade shouting advice. Two practical men shoved forward and stretched their hands down to Charles. First he passed up his bundle of papers, then he consented to be lifted out.

Patrolman Schnitzer of the bridge squad came up and took the mean devil's victim to the police room at the Manhattan tower. Dr. Orr arrived in an ambulance from the Hudson street hospital and the boy was stripped. Not one burn was on him. Dr. Orr and the police thought it was amazing that Charles had not been killed outright. They told the boy he could go home.

Charles delivered the papers intact to the newsmen at Catherine and South streets and asked for his 15 cents. He had received to end with all connection with the devil. He was told he would be paid later. Then he slipped into his home.

He said nothing, but eventually the news penetrated the circle of his neighbors, there reached eleven-year-old Mary, his sister, and then, of course, got to his mother.

In the college halls he does not hear teachers with opposing doctrines to lay before his mind for a critical choice, as is the case with the universities of Europe. He is not asked to balance arguments and choose his opinions. His opinions are handed to him to be learned by memory. There is just as much lack of independent thinking or healthy conflict of theories in some of our college faculties as in the undergraduate body.—Owen Johnson, Author of "Stover at Yale."

While it is doubtless impossible to expect our models of public opinion to learn Japanese, the next best thing is to have them visit Japan. They will then know justly well how to handle the examples whenever uttered by our yellow journals or by the Lodges, Hayburns and Hobsons of our congress. If there is ever any trouble between the United States and Japan it will be because we deliberately seek it or else because public opinion in America is allowed to be kept in ignorance of the true attitude toward us of our great and long forbearing sister nation across the Pacific.—Hamilton Holt.

### PRAISE OF THE OPEN AIR.

I think that I cannot preserve my health and spirits unless I spend four hours a day at least—and it is commonly more than that—sauntering through the woods and over the hills and fields, absolutely free from all worldly engagements. You may safely say "a penny for your thoughts" or a thousand pounds. When sometimes I am reminded that the mechanics and shopkeepers stay in their shops not only all the forenoon, but all the afternoon, too, sitting with crossed legs, so many of them—as if the legs were made to sit upon and not to stand or walk upon—I think that they deserve some credit for not having all committed suicide long ago.—Thoreau.

### PAN-AMERICAN MISUNDERSTANDINGS.

In a number of the Latin-American republics, especially those less advanced and less fortunate in their internal affairs, it is the regular custom in some quarters to insult the fair name of the United States of America by making it the plaything of intriguing politicians. The machinations of such selfish schemers, supported by the yellowish element of the local press, strive to secure the misstatement of American policy and to impose upon local public opinion. What a painful spectacle this is to all honorable and patriotic citizens of the American republic! How long shall such sinister propaganda, obviously for ulterior and unworthy motives, be able to exert its baleful influence upon the American people? Such beguiles are used to frighten the masses should not be imposed upon grown men. Here in the United States, too, at times we do harm with thoughtless writings in which the self hypothesis of a brilliant journalism fails to sleep the nobler and more essential qualities of truth and patriotism. At times we are more ready than we should from the effects of loose and uninformed talk of our foreign relations by persons whose names give to their words authority in spite of their lack of official responsibility.—Secretary Knox.

### PAN-AMERICAN SENTIMENT.

The sentiment of pan-Americanism has ceased to be a mere state of mind and has begun to reveal itself in deeds, in practical efforts and in results. The movement you have set on foot and which we Latin Americans so warmly espouse gives us the right to reclaim for us all the title of Americans, which you North Americans have appropriated to yourselves, for the name of America should not, as you would often have it, be confined to this portion, great, wealthy and populous, but nevertheless only a portion of this American continent. Mexico stands shoulder to shoulder with you, doubt it not. We Mexicans love, perchance, with fanatical ardor, what is truly ours—our language, our history, with its tears and its joys; our liberties so dearly won, our independence. Yet we possess a mind ready to receive and welcome great ideals. And what I say of Mexico I feel authorized to add of Guatemala, as well as Salvador, of Honduras and of Nicaragua, for of Costa Rica, of Panama, of Cuba, of Santo Domingo and of Haiti. The Latin spirit is everywhere the same, ready to scale the loftiest heights of human sentiment.—Manuel Calero, Mexican Ambassador.

She is survived by her husband, Mr. Henry Dougherty, of Baltimore, and by two children.

Mr. Eljah Davis died at the home of Mr. William Davis near Fruitland on Friday evening, June 28th of Bright's Disease. Mr. Davis was somewhere around sixty years of age and had been a life long resident of this place. He married a daughter of Mr. David Kelley, who having died seven years ago with cancer. He leaves two sons, Joseph and Elsie. Funeral services were held Monday afternoon at the home, by the Rev. H. S. Dunlavy, and the remains were interred by the side of his wife on the John Freney farm.

He may not be a politician and we sincerely thank our "stars" that he is not, at least in the sense of the term so often used. He owes neither his popularity or nomination to political manipulation or underhand schemes but to his open direct method of dealing with whatever has come up. He has convinced the people of his honesty and sincerity, and has clearly shown that he is no "trimmer" but boldly takes his stand for what he thinks is right and bravely abides by it.

While a progressive he is no radical and the honest business interests have nothing at all to fear from him, and we mistake the spirit of those men very much if most of them will not be found supporting him in this campaign.

Whether Mr. Roosevelt runs or not is immaterial to the success of the ticket this fall. If he decides to run the Democrats can afford to watch the fight between the two leaders of the Republican party and see the primary fight all over again, for neither can expect to get any material support from the Democrats. While Mr. Roosevelt is very popular among the progressives, there is certainly no reason why a progressive Democrat should not support Mr. Wilson with enthusiasm, and he will have to depend upon the vote of those whose sympathies are with the Republicans for his votes.

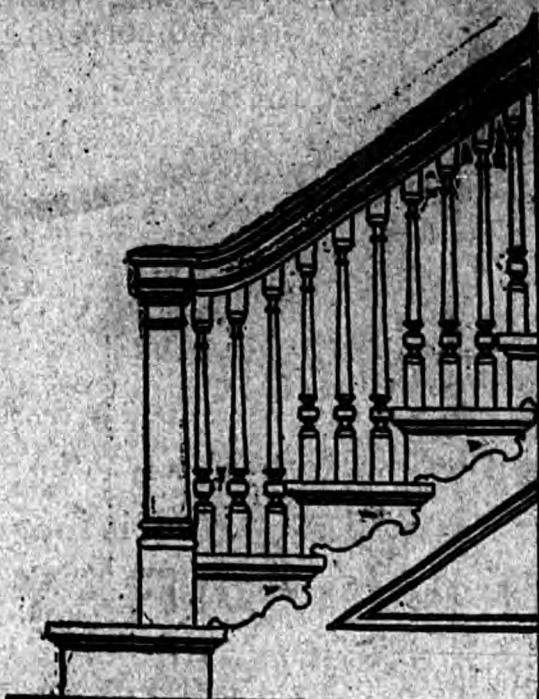

## LOOT WAS QUICKLY RETURNED

Advertising of a Mexican General  
Who Was as Good as  
His Word Brought Results.

Parrot, Mexico, has just illustrated the old adage that it pays to advertise. And the illustration is so plain that even those people who believe in advertising that it is worthy of comment.

Recently General de-So gave out an interview to the afternoon paper which said that, unless the people who had been working at collecting loot changed their ways, he would cut their heads off. There had been a pretty fair fight or two in Parrot streets and while the soldiers were engaged in combat others, not so busy, swiped nearly everything that was loose. So the general said that in homes where loot was found, it would make it necessary for him to amputate the heads of the guilty perpetrators. The paper printed it, and from the time of the appearance of the first copy on the streets there was a stampede to be the first to return stolen property.

By the break of dawn the next morning the streets in front of the city building were a mass of drays, wagons of all descriptions and persons in carriages, on horseback, with many "citizens on foot," with loot to a far-you-vell. A quarter of a million dollars' worth of plunder was taken back and deposited with the best wishes of the plunderers in front of the magistrate and thus one of the biggest advertising campaigns was proven efficient.

In the bunch were shoes worth fifty thousand dollars, shoes of all sorts and sizes and conditions. There were English shoes, Lynn, Massachusetts shoes and home talent shoes from Mexico.

There were mantillas, for a milliner store had been looted, and there were ready-made clothes, for these emporiums had also been included in the plundering.

But the advertisement of a man whose word was known to be as good as his bond, as any advertiser's should be, brought the business and so much of it that the city was almost put out of joint as the result.

## COLUMBUS POOR ADVERTISING

How He Might Have Made His Famous Voyage of Discovery a Profitable One.

"The man who invented the printing press certainly started something," Lawrence O. Sherman, Republican candidate for United States senator from Illinois, told the members of the Chicago Advertising association in a speech the other day. "It remained for the advertiser to add to the top story so the public could use it. The resulting volume of activity since the original invention is something astounding."

"If Columbus had been a good advertiser, the queen would not have been compelled to pawn her crown to outfit his investigating committee. He could have sold space on his three ships for money enough to finance the whole enterprise. He was too modest, however, and so the family diamonds had to go. History has preserved everything but the name of the pawnbroker. If he had been a good advertiser his house would still be in business and loaning money to the crowned heads of Europe who are short on cash."

Just one has a good thing, he must hunt him up. It is his business to hunt them up or reach them with desirable information. The medium of communication must be instantaneous. Few people will solve puzzles to find out the name of something to buy. Advertising is an art.

"An advertisement must be truthful. A falsehood cannot survive. All legitimate business must be permeated with honesty and truth. Advertising must be on current terms, or prepared so as to attract. It is designed for live persons who are busy most of the time."

Only Makes Success Greater.  
Advertising is a potent force in the building of a business and the broadening of its sales. But it is not all powerful. The only people who can use advertising as to realize on its maximum possibilities are those who could succeed on their own sales ability without printed advertising. Advertising helps to make their success greater. It doesn't supply the principles of success.

## POLTRY

## SCALDING A FOWL PROPERLY

Any Aged Bird May Be Treated Without Injuring Its Quality If Handled in Right Way.

So great is the possibility of scalding the fowl improperly that dealers in some localities show an inclination to demand dry plucked fowls. As a means of overcoming this difficulty, C. K. Graham of Connecticut, who has spent a good deal of time in studying the subject, offers these suggestions: Any aged bird may be scalded without seriously injuring its quality if it is properly handled; but owing to the large number of poorly dressed scalded fowls, the marketmen place a premium of from 1 to 3 cents a pound on dry plucked stock.

Boiling water may be used, but care must be taken not to leave young birds in the water too long, or the skin will cook, while with old fowls a little more time may not do any harm. The head and shanks should be kept out of the water, as the scalding will discolor them and make them unsightly. Immediately after the bird is taken from the scalding water it should be dipped into cold water to stop the cook, and, as poultrymen say, to "plump the bird."

The bird should then be hung as for dry plucking, as no bird plucked on the lap or the table will have so good an appearance. If a scalded bird is exposed to a draught when being plucked or when cooling, the skin is likely to harden and become rough. It is because of these possibilities that dry plucking is recommended, as the condition of the skin to a great extent accounts for the high or low returns received.

## MOVABLE ROOSTS AND NESTS

Nothing More Convenient in Cleaning Than Long Saw-Horses in Flight Against Little Parasites.

After trying all sorts and types of roosts and roost-poles, I am convinced that nothing is better than a long saw-horse, says a writer in the Farm, Mall and Breeds. A roost of this type, set on a smooth floor, and with removable nest boxes, makes it possible to keep the henhouse perfectly clean at all times. The main difficulty experienced in cleaning the house is the obstructions, these being usually the roosts and nests. If they can be taken out quickly and handily, and nothing left but a bare room with a smooth board floor, the work of cleaning becomes an easy task.

Once a week I give the henhouse

a cleaning. The nest boxes are first taken out, the straw dumped and burned and the boxes themselves whitewashed and aired. Before being returned they are supplied with clean straw. Treatment of this sort is "death on bugs."

The saw-horse roosts undergo the same cleaning process, being taken out, brushed and whitewashed. The henhouse floor is then swept clean and the whole interior given a new sprinkling of whitewash. Should lice or mites be manifest, an additional treatment of chloride of lime is given, but this is seldom necessary.

### EASTERN SHORE TENNIS

Tournament—Remarkable Growth of Interest—New Plans—Initiation Tournament Proposed.

This year, owing to the improved opportunities for playing afforded by the Talbot County Club, the interest in this good, clean sport has increased still more. The Club has four of the finest dirt courts in the State, which are kept in perfect playing condition by experts, and no wonder the number of those who have taken up the game has greatly increased.

In a recent Club tournament, for which the Governors offered prizes, nearly fifty members competed. They are not all Dohertys, by any means, but we speak of the interest manifested rather than of the quality of the play. The Country Club will continue its generous support of the game by offering monthly prizes for the encouragement of the game, especially of beginners. So the progress is kept up.

The time has come when the Eastern Shore must have its own Open Tournament, similar to those held in Delaware, and other States.

This brief article is intended for those, in any section of our territory, who are likely to take some interest in carrying this project into effect. The Talbot County Club has been approached on the matter and the Governors have given their consent to have their Courts and Club conveniences used for the purpose, and finer are not to be found anywhere. The plan is to devote three or four days to the Tournament. The events would consist of ladies' singles, ladies' doubles, mixed doubles, men's singles and men's doubles. A Challenge Cup is also proposed.

Of course, more detailed arrangements must await the developments of the next few weeks, but it is hoped that all our towns and cities will take the matter up. Meanwhile, all who are interested are urged to write to Dr. Davies, at Eastern, for information, and to stir up their Tennis friends to enter into this plan. All are invited to take part and come to think of it, what better way could you enjoy a short vacation than in friendly sport amid the ideal surroundings of Old Talbot and its Country Club. Try it.

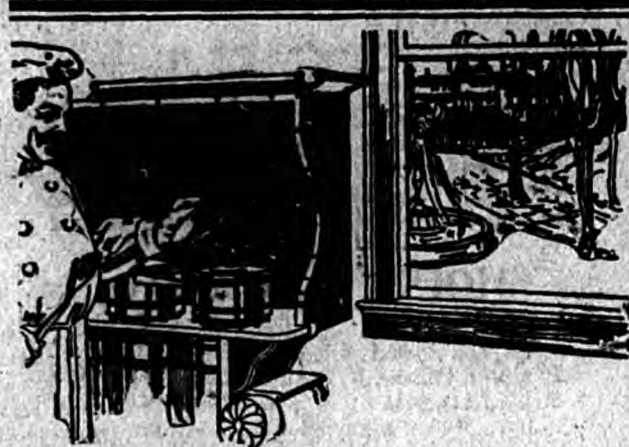

## Advertising Talks

### ADVERTISING HOPE OF HOME

How a Woman With a Wife-Beating Husband Secured Remedy That City Officials Denied.

A young man applied, administered the prescribed treatment, received his wage and went off smiling.

The woman said she had applied for relief to the mayor, the chief of police and the prosecuting attorney without satisfactory results, but when she advertised in the advertiser she secured instant response. All of which goes to show that if you want a thing done advertise for some one to do it for you.

The business of beating wife beaters is one that should appeal to busy young men who carry "a kick in either mitt" and, likewise, "the punch," comments the Wichita (Kan.) Eagle. It is a form of civility, and we might expect soon to see established in large centers of population an order, the Knights of the Ready Fist, or the Society for the Discouragement of Wife Beating. The newspaper columns may carry many advertisements, not only those placed by wives who have been beaten, but by active and progressive human thrashing machines, who will appeal thus:

"Wanted—By enterprising and ready young man, the position of thrasher of husbands who beat their wives. Husbands weighing under 165 pounds preferred. No wives with husbands weighing over 165 pounds need apply. Can punch with either hand."

Of course, if there is too much of this witty retaliation and hired sabotage introduced into domestic life, husbands addicted to the habit of wife-beating may form a combination and hire their own defenders.

The moral of the whole matter is, however, that it pays to advertise. Let any maltreated wife now say to her bully of a husband: "If you are not good I'll advertise."

The end of wife-beating is in sight, and yet some say the newspapers do no good!

### DROP ALL AD. SCHEMES

Laporte (Ind.) Merchants Sign Agreement to Patronize Nothing But Newspapers Hereafter.

Merchants and professional men of Laporte, Ind., members of the Merchants' Association, to the number of 50, have signed an agreement, under which they bind themselves not to patronize any individual scheme of advertising other than those offered by newspapers of Laporte county or bona fide publications. In the office or place of business of every signer of the agreement a card has been posted setting forth the agreement and being explanation sufficient to the advertising solicitor why it is impossible for him to do business with members of the Merchants' Association. The text of the agreement follows:

"We, the undersigned business and professional men, do hereby agree, among ourselves and with the Merchants' Association of Laporte, that from and after April 1, 1912, we will positively refuse to patronize any individual scheme of advertising other than those offered by newspapers of Laporte county or bona fide publications."

"Program advertising, donations, tickets and all such similar schemes that have been the cause of so many unjust demands upon us are especially referred to in the above agreement, and from the date mentioned we bind ourselves to the agreement, signed herewith, pledging our word that no such scheme will be aided by us, either individually or collectively, unless the same be first endorsed by the advertising committee of said Merchants' Association of Laporte."

### Had to Agree With Gladstone.

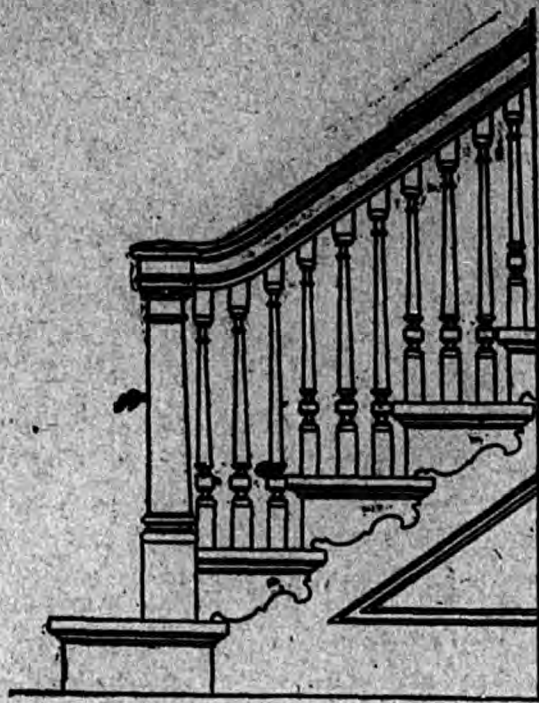




