- 2. Announcements from the Senate President
  - a. 2017 SUSRC Outstanding Research Mentor Award has been awarded to our own Chrys Egan Congratulations!
  - b. Successful Defense, Congratulation to <u>Dr.</u> Melissa Boog, who is co-chair of the Gen Ed Steering Committee and who has worked so closely with Faculty Senate over this last year.

- 4. Unfinished/Continuing Business
  - a. Gen Ed Revised Student Learning Goals Motion Dr. James King.

    May 2 Gen Ed meeting did not have a quorum so this document is being revisited with intention of having either acknowledgement or revision. <u>Discussion:</u> The revised version has some new language on sustainability. What do we mean by diversity? It can mean so many things. Electronic version could have links to more details like definition of "diversity." Live, learn, and lead: What about followership? Comment that following is implied in effective leadership, and that citizenship also includes followership.

Motion: Faculty Senate acknowledges this General Education document on the Revised Student Learning Goals. Motion passes unanimously.

- b. Department Chair Service, Promotions Committee Charge tabled from the last meeting, this charge is being sent from the Faculty Senate President to the Committee on Promotion with a report back to Faculty Senate by the end of October 2017.
- c. Honors College Policies & Procedures Revision tabled from the last meeting, President Ford indicates that the first revision date on the document is incorrect and needs to be fixed and that the document primarily reflects the move from Honors Program to Honors College.

<u>Discussion</u>: Section 2 on Honors Committee – What happens if Honors Committee makes recommendations to the Honors Dean, but those recommendations are not followed? Answer is that the committee is one of the Faculty Senate and can report concerns to us. **Motion:** Faculty **Senate acknowledges this Honors College document on the Policies & Procedures. Motion passes unanimously.** 

## 5. New Business

a. SU Website Redesign Project - Sue Eagle, Asst. VP Marketing & Public Relations
Two year process to redesign SU's website in alignment with enrollment goals but will
impact all aspects of the site. Marketing best practices will be utilized with strategic content
and searches, and be ADA compliant. Process includes: discovery with on-site meetings,
customer journeys on the site, visual design, content revision, and site development. Shared
governance organizations are asked to be actively involved starting in August or September
2017. Current data: 16.5 million page views last year, with 2 minute and 9 seconds as
average time.

<u>Discussion:</u> Many faculty have information point of view rather than marketing, so how will those be aligned? Answer is that our site has many functions and we do not want to lose that. Highest rating on our current site for users' ability to find information. Express thoughts and concerns in discovery phase so that site is useful to everyone. Outside consultant in higher education will conduct the process. Main audience is students, but there are 12 audiences, and they will be consulted.

b. Campus Facilities Changes - Eric Berkheimer, Assoc. VP Facilities & Capital Management Displayed images and maps of east campus renovation plans.

<u>Discussion:</u> Will contractor be responsible for the cracked tennis courts? The answer is yes. Questions were asked about facility storage and tentative park pavilion. Eric was asked to discuss the Tri-State Engineering building off of Milford Street\_and he responded that this was recently purchased and will become an academic building to house the three-dimensional arts programs (sculpture, hot glass, ceramics) It will double the amount of space currently available in Fulton Hall for these programs. The expected opening is late 2019.

c. Passing of the Gavel – Sam Geleta, incoming Senate President. The incoming President thanked the outgoing President, Stephen Ford for his excellent leadership. He also extended his thanks to the outgoing senators for their service. He welcomed the newly elected senators to the 2017/18 Faculty Senate and wished them success and looking forward to working with them.
