

Robbery Declared A Fraternity Prank

At 10:45 p.m. last Thursday night, as Leslie Noble, a Lane Center employee, was preparing to close an hour early, she was accousted by a mysterious male wearing a ski mask. When Ms Noble asked if she could help him, the man wordlessly handed her a note explaining that he was armed with a Thompson sub-machine gun and that he would open fire unless she met his demands. In the note, the man went on to demand all the green M & M's and all the red jelly beans in stock, as well as all the Fruit & Nut mix, minus the raisins.

Noble reported that the man waited patiently for 20 minutes while she and the night manager carefully sorted the M & M's and jellybeans and removed the raisons from the mix. The man then accepted the packages, nodded, and exited nonchalantly through the front door of the Lane Center.

Campus Police were notified immediately, but did not arrive at the scene for nearly half an hour, owing to some mix-up in the dispatching system. Police Chief Merican declined to comment further on the cause of the delay, but was later heard muttering about "that stupid supplemental security plan" and cursing "that Rob Lippman and his bright ideas."

Once the police arrived, Ms Noble informed them that she had cleverly punched a hole in one of the bags, thereby causing the retreating thief to leave a trail of green M & M's in his wake. Police quickly picked up the trail, following it from the Lane Center to the Library, all the while collecting, counting, and labeling each M & M to use later for evidence.

When the officers arrived at the library, they soon discovered a discarded ski mask on the desk by the telephone on Floor 3. Police questioned the desk librarian, who reported that the owner of the ski mask had been seen trying unsuccessfully to make an off-campus call on the library campus phone.

"Watching people struggle with that phone is usually the funnest part of my job," the librarian allegedly reported, "but this guy was spilling M& M's all over the floor. I finally ordered him to take his candy to the proper area on Floor 2 or else leave. He left."

Pausing just long enough to have the librarian fill out a written statement and to take fingerprints from the phone, the Campus Police quickly resumed following the M & M trail, which led to the library exit. Here they were again delayed when they activated the metal detector system. Claiming that "rules are rules," the desk attendant forced police to surrender their revolvers, ammunition, badges, and clipboards before allowing them to pass through the turnstile.

Hot on the trail, police tracked down the suspect on Loop Road, where he was asking a passing student for directions. Police immediately seized the thief and searched him for weapons, but they found only some loose change, a Dutch-English phrasebook, and the name and address of the Tau Kappa Epsilon fraternity president.

The suspect spoke only a little English, but by tossing the phrasebook back and forth, the police were able to learn that Cont. on pg. 4

Because of the high swirling winds Sunday night, Fredrick Hall residents were asked to evacuate for fear that their dorm would be next. And sure enough, by the time the fire company had arrived Fredrick Hall was in flames.



Nuclear Energy Workshop

This Tuesday, April 5th, Dr George Plitnik of the FSC Physics Dept will present the 5th in a series of highly successful Alternate Energy Symposiums. The workshop is entitled "Nuclear Energy: It'll Glow on You," and it will be held from 3:00 till 5:00 p.m. in Tawes Hall.

Some student and faculty may remember the other successful workshops held in the past. These include a Geothermal Energy Workshop entitled "Geothermal: Under Where?"; a Wind Energy workshop entitled "Passing Wind Can Save you Bucks"; a Solar Energy workshop, imaginatively titled "Plitnik: Sun God?"; and finally, a workshop on Hydroelectric power, which was titled "The Whole Dam Thing."

This Tuesday's workshop will open with the unveiling of the new FSC Nuclear Reactor, which Dr. Plitnik has constucted in the Planetarium on third floor Tawes. Plitnik explained that the Planetarium was chosen as the site for the reactor because of its suitable dome shape and because of its central location on campus. "The central location makes it easier to

This Tuesday, April 5th, Dr channel the nuclear energy we orge Plitnik of the FSC Phys produce to many different buildings on campus," said Plitnik.

A discussion will follow the unveiling ceremony. Topics to be covered include procedures for building your own minireactor, methods of obtaining fuel from the black market, and streamlining waste disposal. Plitnik had originally scheduled a special lecture on "Ways to Get Around Federal Regulations," but this presentation had to be cancelled when the Reagan administration eliminated all the environmental and nuclear regulations that were scheduled for discussion.

Several eminent world leaders have announced that they will be attending the seminar. Those expected to attend include the Energy Commissioners and Chiefs of Staff of Pakistan, Iraq, South Africa, and Cuba. "We should have quite a turnout," Plitnik remarked, "everybody's just dying to see the new reactor."

The FSC Nuclear Reactor is the result of 2 months of hard work on the part of Dr. Plitnik and his assistants. Naturally, Con't on page 4

Vew Visitation Policies Announced

The office of Student Affairs announced today that a few new housing regulations have been approved and will be effective immediately.

From now on, dorm residents must sign in and out of the dorms and must write down where they are going, who they will be with, and a number where they can be reached. The sign-in records will be reviewed by the new dorm mothers/fathers, who will be living in the

dorms starting tomorrow. The Houseparent will report any unacceptable conduct to the Residence Life Office. These houseparents also have the authority to place students on restriction or to take away their car keys if their behavior is judged to be unsatisfactory.

C0-ed dorms will be eliminated-Cambridge and Westminister will now house only females, while Fredrick and Annapolis will house only male students.

certain precautions were taken to ensure that no one was hurt by the radio-active material. For example, Plitnik chose only off-campus students as his assistants. "That way, they won't track the stuff into the cafeteria," he explained.

In addition, Plitnik insisted that everyone wear thick wool mittens when handling the radio-active material. To avoid inhaling too many particles, one assistant suggested that they use surgical masks. Plitnik was skeptical, however, and in the end he decided the masks were a waste of money and simply ordered everyone to breathe less.

Nuclear wastes were no problem as these were collected regularly and then conveniently discarded in nearby sinks and water fountains.

In the course of two months, several small mishaps occurred, but these minor spills were easily controlled by the crew. "We just wiped them up with a damp sponge," noted one assis-

their suspect was Lt. Bas Akkerman of the Royal Netherland Navy. Lt Akkerman had served as yeoman to his uncle, Capt. Fred Akkerman, who was a member of the NATO briefing team that had visited FSC on March 11th. Akkerman had been inadvertantly left behind when the team departed before spring break.

Since that time, it was discovered, Akkerman had taken up residence with member of Tau Kappa Epsilon fraternity. The fraternity members, who were desperate for pledges, offered Akkerman free room and board at their president's home if he would pledge their fraternity. Since he didn't have the money for plane fare, the Lt. had agreed.

Akkerman reported that he had often been sent to pick up mysterious packages from various addresses as part of his pledging activities. Because he could not read the note he had handed to Ms Noble he had assumed that he had been sent on simply another pre-arranged

One serious accident occurred two weeks ago, when a meltdown involving the reactor caused radioactive material to drip down into a second floor classroom, where an Organic Chem class was in progress. The classroom was evacuated, but several students, who were irritated at being awakened, voiced their complaints to Dr. Plitnik, who told them to wash their hands and shut up.

Another major accident was prevented when a team of fastworking housekeepers in Tawes hurried to the scene of a major spill on 3rd floor and mopped up the spill using damp mops and paper towels. The spill was caused by pressure build-up in reactor. Housekeepers replaced the marred finish of the floor with a new coat of wax. "Now, the floor is so bright and shiny, it almost glows," said one housekeeper.

The energy produced by the reactor will be used to power electron microscope in Tawes, to provide heat for the indoor pool and saunas in Allen Hall, and to power the new light-

drug deal.

When questioned by police, the men of TKE denied any connection with the candy counter robbery. They claimed that they had been set up by a rival fraternity, and that Akkerman had been paid to indict them. TKE president (name withheld) demanded to know where Akkerman had gotten his address, and derisively referred to the Lt. as "the lying Dutch-

Campus Police have decided to release Lt Akkerman to the Dutch Embassy in Washington. He will be flown back to the Netherlands, where he may face AWOL charges.

Meanwhile, Francie Coghill, Campus Activities Advisor, has warned TKE that they may be brought before the Judicial Board on charges of hazing

Until the facts can be sorted out, Campus Police will take no further action in the case. Once the guilty party is determined, however, he or she will be forced to make restitution to the candy counter for the stolen merchan-



For a short while, this incriminating broadcast was heard only by a few off-campus listeners, but at 2:45 p.m., the Lane Center Director decided to change the station playing in the Lane Center from WKGO 106 to WRQX 107. In so doing, he passed over the WFNR frequency number just long enough for everyone to hear Child's voice boom out "Dave, how are we gonna sell 3 ounces of black hash?"

Within minutes, Compton Hall was swarming with interested students. Campus Police were notified that a riot was in progress, and four officers were dispatched. By the time the police arrived to dispel the riot, however, Kahn and Childs had sold the last gram and were pocketing the proceeds. One disgruntled student who had missed the sale informed the police of the true cause of the gathering, and the officers immediately began to search the station.

They discovered \$200,000 worth of cocaine cleverly concealed in a speaker, as well as ½ lb of HIGH-quality marajuana cleverly hidden under Kahn's jacket. The two students were also carrying each in small bills.


The Athletic Affairs Committee unanimously agreed that Mr Coleman had done more than any other athlete to help FSC to win many of their competitions.





Men's Track Wins Towson Invitational for Fourth Straight Year

The Frostburg State Track team set a Towson State Invitational meet record on Saturday (March 27) by compiling 124 and 1/2 points to easily win the meet over 33 other colleges and club teams.

Coach Bob Lewis' squad, winning for the fourth straight year, finished ahead of runner-up Indiana University and Catonsville Community College. Other schools competing included Slippery Rock, Towson State, Morgan State, and Millersville State.

By scoring 18 1/2 points, junior Mark Williamson was the second leading scorer of the meet. Williamson won the high jump, was a member of the winning shuttle hurdle relay, and placed in two other hurdle events.

Other top individual finishers for FSC were by junior Rich Hoffman, first in the 10,000 meters; junior Tim Street, second in the 100-meter dash with a national qualifying time of 10.5; freshman C.A. Webb, second in the pole vault; sophomore Duane Thomas, third in the 800-meter run; senior Dan Quinn, third in the 10,000 meter run; and senior Wayne Mattison, third in the triple jump.

Frostburg's 400-yard relay team consisting of Street, Allan Pleasants, Bill McKinney, and Wilbert Allen finished first, as did the shuttle hurdle relay team of Williamson, David Arthur, Bas Prins and Robert Stanley.

After a triangular home meet on Tuesday (March 30) with West Liberty State and West Virginia Wesleyan, the Bobcats will compete on Saturday (April 3) at the Davidson Relays in North Carolina.

Krotchko Seventh in the Nation in the All-Around

Frostburg State College gymnast Mike Krotchko was the seventh-place finisher last week (March 23-25) in the all-around at the NCAA Division II-III Nationals held at Springfield College in Springfield, Massachusettes.

Krotchko, a sophomore from Linden, New Jersey, was just one place shy of earning All-American status. His score of 50.10 included a school record 8.85 on the high bars and scores of 7.95 on the floor exercise, 7.75 on the pommel horse, 8.55 on the still rings, 8.95 on the vault and 8.35 on the parallel

Last year, as a freshman, Krotchko was 16th in the nation in the all-around.

Frostburg's other qualifier, sophomore Ken Dougherty did not place in the top 18 with his score of 7.95 on the pommel horse, his specialty.

Bobcats Drop Two to Slippery Rock

For the Frostburg State baseball team, this week (March 30-April 5) will give a true indication of just what to look for during the 1982 season.

The Bobcats will play five doubleheaders during that time with hopes of improving their 3-4 early going record.

After Tuesday's (March 30) twinbill at Pitt/Johnstown and Thurday's (April 1) tow games at California State, Frostburg will play three consecutive days of doubleheaders.

The three twinbills in a row begin on Saturday (April 3) when FSC hosts UMBC, then the Bobcats entertain Coppin State on Sunday (April 4), before traveling to Deleware State on Monday (April 5).

Last Sunday (March 28) the Bobcats were drubbed by Slippery Rock, 12-0 and 17-5, to stop FSC's three-game win streak. The only real standout for Frostburg was junior first baseman Dave Zittle, who went 3 for 4 including a run-scoring triple.

Zittle leads all Bobcat regulars with a .500 batting average followed by Stu Shelley at.364, Tom Beley at .353, and Pete Erwig hitting .333.

Laura Schlegel, National Champion

Sophomore Laura Schlegel won the 200-yard backstroke at the NCAA Division III Swimming and Diving Championships on Thursday, March 11, to become Frostburg State's second individual national champion.

Schlegel finished with a time of 2:12.15 at the national championships held at the University of Massachusetts in Boston.

A triple All-American last year, Schlegel also finished third in the 100-yard backstroke and ninth in the 50-yard backstroke while leading the Bobcats to a 17th place finish among 44 schools that qualified.

Also competing for Frostburg were junior diver Marrianne Lewis who was seventh in the three-meter diving and Alicia Bobesink, who was 15th in her specialty, the 50-yard breast-stroke.

The 400-medley relay team of Schlegel, Bobesink, Laura Chapin and Paula Schaeffer was disqualified due to a false start.

FSC's only other individual champion was Carl Schueler who was a national champion in the race walk in 1976.

On March 11-14, Laura Schlegel left for the national swimming competition at University of Massachusettes—Boston. After competing in the 200-yard backstroke and finishing with a 2:12.5, she found out what it is like to be given the coveted title of an All-American. "I feel fantastic about it!" she admits with the perfect blend of modesty and appreciation.

Having drempt of being a national champion since she started swimming at the age of 10, Schlegel has come a long way, trailing behind her a long line of records, titles, and awards. Currently she holds at least 8 records for Frostburg's women's swim team. Included among them are the 50-, 100-, and 200-yard backstroke, the 100-, 200-, and 400-yard indivdual medley, and the 200- and 500-yard freestyle.

Through much support and urging from her father, Schlegel started swimming for therapeutic reasons as she had Asthma. Realizing her ability and potential, she joined the Montgomery County Swim League and continued the sport at Paint Branch High in Silverspring. "There were many times when I just didn't feel like swimming anymore, but my father always gave me enough encouragement to keep me going," she notes with no regret. After see-Frostburg's exceptional swimming facilities and hearing good reports of the swim teams, Schlegel had no problem choosing the right college for herself.

After almost 2 years at FSC, she still has no complaint. (It's great swimming with the people here, and "Doc" (coach Bob McFarland) is great—always there when you need him." INstead of transferring as she had earlier planned, Schlegel hopes to graduate from Frostburg with a Business Adm degree in '84. Meanwhile, she has set high goals for her swimming career.

Having been named AIAW All-American in '82, Schlegel doesn't want to break the chain. "Now that I have this title, I want more," she admits with a smile. She realizes it will be difficult to keep her title, but for starters, she hopes to qualify in more events and to improve on her own individual scores. "Practice is the Key," she says.

And she knows what practice is. The team spends 2 hours, 5 times a week in the water, 45 minutes, 3 times a week lifting, and 2 times a week working on flexibility. Sometimes it's a tough schedule and a long season, but she has learned to manage her time well. Consequently she got the payoff.

"It's a good feeling being All-American, and I really have to thank the team and the coach," Schlegel comments sincerely. She admits that without the cheers and support of her teammates or the encouragement and advice of Coach McFarland, victory would not be as easy and could never feel as great.

Noted Economist and Libertarian Visits FSC

The Frostburg State College Foundation, Inc., in conjunction with the FSC Cultural Events Series announced a lecture/discussion by the prominent economist Dr. Murray Rothbard on April 6 at 8 pm. in the Lane College Center.

Dr. Rothbard, a professor of onomics at Ploytechnic Institutes of New York, is the editor of the Journal of Libertarian Studies and an officer of the Center for Libertarian Studies. Dr. Rothbard has lectured at most major universities in the country.

Elimination of Gymnastics Teams Under Consideration

A state-initiated cut in funds for contractual faculty may result in the loss of the Men's and women's gymnastics teams.

denied the funds to support 2 of the 9 contractual positions on campus. One of these positions will probably be retained

The State Budget Analyst has

by using alternate funds, but the other position is likely to be eliminated.

Although nothing is definite yet (except the State budget cuts) Deans Cotton and Kealy and Acting President Jablon

have indicated that the position cut will most likely fall on

Ms. Margie Schaeffer, the women's gymnastics coach and one of the two dance instructors in

the P.E. Dept. The Deans based their decision on an evaluation of credit hours generated by

various depts relative to the number of faculty members. Of all the depts. having contractual

faculty members the P.E. Dept generated the fewest credit hours per sinstructor.

Some P.E. majors objected that the number of credit hours generated per hour of actual

teaching was less in the P.E. dept than in other depts. Kathy Butler pointed out that P.E.

instructors teach three hours, while other instructos teach three hours for three credits. In

response to this objection., Dean Cotton note noted that many other dept's have similar prob-

lems (e.g., the Biology and Chemistry Depts. encounter a similar situation in their lab

classes) and he stated that there was no objective means of translating credit hours spent

lecturing. "We have to use the available standart means of evaluation," Cotton said.

If Ms. Schaeffer's position is eliminated, both the men's and women's gymnastics teams will

be cut because, according to Title 9 (which bars sex discrimination) the dept. may not cut

a women's sports team without also cutting the men's team. The possibility of combining the men's and women's teams and having Mr. Kutler, the men's gymnastics coach, take charge of

both teams. Most of the women gymnasts, however, feel that this solution will lessen the quality

of coaching by forcing Mr. Kutler to divide his time and provide instruction in certain

women's events (e.g., balance beam, uneven parellel bars) which her has not recently coached. Another possible solution is to have a graduate assistant coach women's gymnastics but members of the team feel that this option lessen the quality of coaching to an even greater degree.

Possible solutions are still being debated., but in all likli-

hood, both teams will eventually will be cut, from the sports program.

There is however one possible resolution of the problem which Schaeffer and her team sup-

port- a one year "stay of execution" for the gymnastics programs. There is a possiblity

that funds can be drawn from such sources as building and pool rentals, summer camp

gymnastics clinic proceeds, and locker rentals-enough funds to provide Schaeffer's salary for

another year. A similar arrangement was made for Tennis coach Richard Walker last year

when his temporary position was scheduled to expire. Ms. Schaeffer feels that an extra year will

allow time for the gymnasts to find comparable programs elsewhere so that they can transfer, and will allow her enough time to select a position at another college.

According to Dean Cotton, however, the costs of maintaining the Athletic program's is on the rise; given the fact there is still much doubt as to whether the college can afford to transfer

funds from other accounts to provide Ms. Schaeffer's salary. In fact, FSC students may be

faced with an increased athletic fee by next year. These athletic fees, which provides for new equipment, uniforms, etc. are put into "Program 18," has been proposed, that part of Schaeffer's salary can be drawn from this program. Dean Cotton noted, however, that the college

may encounter some objections if they use these funds to pay for coaching and then raise the fee next year.

All in all, it is a very touchy situation, and many proposed

solutions are still being reviewed. The Deans are expected to reach a definate decision later this week. At best, the gymnasts can expect their program to continue for another year; at worst, the program will be cut, effective this semester.

One matter on which both Deans and students agree is that the loss of Ms. Schaeffer from the P.E. Dept. is lamentable. Ms. Schaeffer currently teaches 1/3 of all the dance technique classes, and her leaving will undoubtedly cause problems with the newly-adopted Dance Minor. Ms. Schaeffer initiated and taught the Aerobics and Fitness class, one of the most popular courses in the P.E. Dept. She has also done coreography for the annual Student Dance Concert. As a member of the Curriculum Committee, Ms. Schaeffer has proposed a Theory and Analysis of Coaching gymnastics course and is presently working on propósals for Rhythmic Gymnastics and Synchronized Swimming classes.

As for her coaching reward, Schaeffer has increased the

team score for women's gymnastics by 5 points annually in the last 3 years. All current team event and AA record have been set by gymnasts coached by Ms. Schaeffer. She has also achieved a 500 or better record each year, while competing against many scholarship Division I and II schools. This year, the lady gymnasts placed 3rd in the S.E. Division II Regionals.

Dean Cotton agrees that Ms. credentials and Schaeffer's achievements are admirable. tive faculty members," he sta- Award for outstanding Service ted. But he also noted that no contractual positions were guaranteed against budget cuts, and that the college may be forced to cut the position despite Schaeffer's excellent reputation.

Further discussion of the issue will continue, and possible compromises will be examined in the next two days. Hopefully, decision on the matter will be reached by this weekend.
