# Students Donate **\$300** to City

Students at Frostburg State College recently donated \$300 to the City of Frostburg to be used to purchase 10 trees. The trees, which have already been planted, are located in the community park area near the swimming pool.

The trees were donated as part of the City's "Tree-for-All" program. This program is designed to beautify the City through public sector-private sector cooperative effort. The City is presently in the process of planting trees throughout the business district, and the Mayor and Council are requesting that service and organizations fraternal join in the effort to build community pride through the beautification effort.

Don Fry, President of the Frostburg State College Student Association, said that, "The students of Frostburg State College are pleased that they can a rticipate in this mean-

ingful program to beautify the community in which we live." Finance Commissioner John Bambacus noted that the Frostburg State College students were the first to respond, and that they certainly set a positive tone to the community promotion program now underway.

Frostburg Mayor David Linn added that, "this is another example of our close and continuing relationship with the college community." He went on to say that in the past, "students of the College have always assisted the City through several public service projects, and their latest donation of trees to the recreation area will be a very much appreciated addition to beautifying our City."

Program Approved Counseling Psychology

Frostburg State College has received approval from the Maryland State Board of Higher Education to offer a new graduate program in Counseling Psychology. The new Master of Sci-


ence degree program will be implemented in January, according to Dr. Nelson P. Guild, President of the Col-

This is a 36-semesterhour graduate program designed for those persons interested in developing professional skills associated with counseling or helping settings such as health mental clinics, counseling centers, and human services agencies of various types. Admission is open to students who hold baccalaureate degree

which includes at least 12 semester hours, some of them in categorical areas, within the field of Psychology.

According to President Guild, the program represents another increment in the College's development as a broadly-based regional institution. Dr. Guild also said that the objective of the College's Graduate Program is to "meet State, regional, and community needs for graduate education."

Dr. Guild added that the College's remote location places upon it the responsibility to respond to the educational needs of an area not conveniently served by any other four-year and graduate institutions. For industries, business, public and private agencies seeking to enhance the employment of persons in the several human services fields, the availability of a graduate program in Counseling Psychology at Frostburg can only be a supportive move. The program would also lengthen the educational continuum in this field for students pursuing their undergraduate program at Frostburg thereby attracting some of them to both employment and post-baccalaureate study in Western Maryland.



# FSC Awarded Federal Grants

Frostburg State College has been awarded \$96,562 in federal grants for the current fiscal year to implement and maintain two service programs for stufrom low-income dents families. Funds for the operation of Upward Bound and Student Special Services are granted through the TRIO programs of the Office of Education, H.E.W.

Upward Bound, a new program to this area, is designed to encourage lowincome high school students to go on to postsecondary education. The program will serve approxiamately 60 public school students in grades ten and eleven at eight Allegany County schools. Students are offered tutoring , mini-courses, information, counseling, and assistance in many areas. Field trips, recreational, and social activities will be included for the personal development of participants. In addition, students will be granted a stipend of \$20.00 per month for participation. Eligibility for Upward Bound participation is based on family income.

Up ward Bound will utilize the facilities of area high schools and Frostburg State College. A six-week, summer residential component at FSC will be proposed in order to orient students to college as one choice of post-secondary education.

Student Special Services, now in its fourth year at Frostburg State College, is designed to help students complete their college education success-SSS has a compofor the physically nent handicapped in addition to low-income students. The program serves over 150 students in the areas of academic and personal development with activities similar to those of Upward Bound. Through the efforts of the tutoring program and other academic support activities, the academic retention rate of SSS students has averaged 95% over a three-year period.

The program has been cited by federal observers as outstanding in manage-ment and staff expertise.

The staff of the SSS-UB program is combined and is expanding to accommodate the growth of the projects. Dr. Joseph Malak, Coordinator of Special Instructioanl Programs, is the Director of Student Special Services. Mrs. Sarah L. Dohohue is Director of Upward Bound, and the Director for Academic Programs for both components is Mr. Morris Willey.

Jay Hegeman is the Evaluation Specialist, and Ralph Marketto is Liaison Specialist.

months, a period of adjustment and change, the libary staff has already begun planning for future expansion and innovation.

Library Director John Zimmerman, who was responsible for the bulk of the planning of the new building, kept in mind the basic idea to create a convenient comfortable place which would be conducive to study. The plush new building presently houses almost 300,000 items which include 1,200 current periodical subscriptions, 46,000 government documents and 24,000 maps located on close to 10 miles of shelvings. Additionally, the multi-media center is highly sophisticated, especially for a college the size of Frostburg State. The equipment in the center is electronic and includes

audio equipment in soundproof rooms, two photocopying machines and a microform copying machine, all on the second floor.

The last shipment of essential furniture and equipment has arrived and additional items of both have been ordered. Display cases and directory boards are also on oruer.

On the second floor, there are staff members available for aid and information concerning use of periodicals, the multimedia center and curriculum material. Times are: periodicals-1:00-4:30 p.m. multi-media- all hours the library is open except for the last half hour needed for machine shutdown; curriculum materials - 9:00 á.m. - 4:30 p.m.

As the 1976 football season draws to a close, the team takes to the road and leaves its fans a great deal to remember. But it seems reasonable to conclude that what they'll remember most is the depressing fact that the best record that can come out of this campaign is 3-7, and that seems unlikely since the days ahead include confrontations with powerhouses West Virginia Tech and Madison College. For Mike Davis and his staff, the honeymoon, if there ever was one, is over; his tenure as head coach has produced a 1-16 record.

Davis' philosophy is, "If you beat a nobody, you're still a nobody." It's an admirable piece of rhetoric, but, while no one expects him to produce a team of Rose Bowl caliber out of his admittedly limited resources at FSC, a lot of us have begun to ask why, since the close of a 5-5 season under Coach James Crawley, the only team the Bobcats have been able to beat is Geneva, immediately after which Geneva was dropped from the schedule. Additionally, a lot of us are waiting for a return on the huge investment the student body pumps into

the football program besides new uniforms.

Maybe its time for Davis to think about scheduling lesser competition or to get his team to the point where it can perform respectably against the schedule the 'Cats are playing now. At any rate, if Davis can't start bringing home some victories in the very near future, maybe he should step down and turn the job over to

someone who can.

It is unfortunate that so many Frostburg students do not know anything about what is happening in the town of Frostburg. Right here in the midst of student apathy, we, the students at Frostburg, have the opportunity to support a well thought out proposal currently before the council and citizens of Frostburg.

This proposal is the highly controversial Rental Housing Ordinance which is desperately needed to keep rental housing in Frostburg up to minimum health and safety standards.

It is easy to see why landlords are against the proposal, because they would be required to improve their rental properties up to standard levels before licenses could be issued. This would involve varying amounts of money depending on the conditions in each rental property now.

The requirements necessary for licensing a property include such things as: minimum living space per person, standard kitchen and bathroom equipment, minimum lighting and ventilation for each room and stairways, smoke detectors on each floor with sleeping quarters, fire extinquishers and emergency exits, security locks, and off street parking. Certainly some of these improvements require money, but isn't human life and safety more important than money? The landlord will just pass this expense on to the renters anyway.

One hearing on this proposal has already been held, on September 27, where the Mayor and Council were there to hear the citizens' opinions on this ordinance. The landlords were the only people who bothered to make their opinions known to the City Council, and these hearings are all the Council goes on when they make the final decision to either accept or reject this proposal which is desperately needed in Frostburg.

There is one more hearing planned, and if the renters do not make their approval of this ordinance plain to the Council, there is no hope of getting the Rental Housing Ordinance passed into law. I urge all interested students and especially off campus renters to go to this nearing and make your opinions known! If no one cares enough to voice their approval, we will continue have substandard housing, and tradgedies will continue to happen, such as the fire this summer where a graduate lost his life. Perhaps his life would have been saved had the landlord been required to install smoke detectors and fire extinquishers. The landlord would have benefited from this also, since his rental property would not have been completely burned out.

Unfortunately, the date for the next hearing has not yet been set, but there will be signs posted in many campus buildings when the date is known. For anyone who desires more information, I would be happy to try to answer any questions. Ask for Nancy at 689-5637. This is a personal statement and request to other Frostburg students to become involved in a situation that directly involves YOU!

# NOTES FOR CONVERSATION

Once again our beloved State College is in the mist of a controversy. This time the controversy revolves around that hated and seemingly useless thing called a student evaluation. How many times have we had to fill out those questionaires concerning our beloved teachers. After all, they're not important anyway, right? Well, as hard as it is to believe, they are.

Prior to last year when there was just not enough money, the evaluations helped regulate teacher's pay raises. It is my understanding that a teacher had the option to count the evaluations as much as he or she wanted. That way, a teacher who was constantly getting good evaluations could count them more than would a teacher who was receiving bad evaluations.

This brings to mind the question why are teachers getting bad evaluations. I suppose we can rationalize as these teachers do that the students are simply not intelligent enough to comprehend what is being taught

It is this same attitude that bogged down the innovative appeals - process last year. For those of you who forgot that controversy allow me to refresh your memory. The present appeals process states "in case will grades be changed by department heads or the Dean of the College unless, after consultation, the instructor agrees to the change. ." The proposed plan would have had the student, after discussing the grade with the instructor and the head of the department and still not being satisfied, would then submit his or her grievance to the Dean. The Dean, following consultation with the instructor,

the department head, the student, and after seeking the advice of some closer faculty advisors, shall determine whether the student's grievance has shown evidence sufficient to indicate that the grade in question was discriminately, arbitrarily, or capriciously conferred. He may then decide to vacate and replace the grade in question.

The debate which revolved around the proposed plan was between the faculty members who supported the principle of the plan and those who felt no change in the procedure was necessary. The plan was rejected and put into limbo by faculty members who felt that students would abuse the privilege.

I find it odd that this same argument is being used against students conconcerning student evaluations. I for one am tired of being told I cannot have something or will have something taken away simply because a teacher feels I will abuse the power. For those teachers that always expect the worst from the students, I can only point to the insecurity in a system which they have created.

On September 29, the Faculty Assemble voted 50-38 to abolish uations. On October 7. the Student Association voted unanimously in favor of maintaining -the student evaluation. Now it is the decision of the third branch of the tripartite government, the administration, to decide. If a student's voice counts for anything on this campus, I urge President Guild to overturn the Faculty Assembly's decision and give us back those "awful" student evaluations.

#### "Convicted " Rapist Pleads for Assistance in Appeal Effort by Sindia Patterson

Alpha Kappa Alpha Sorority is assisting the Southern Poverty Law Center in petitioning for an appeal of the unfair trial of Johnny Ross.

He wrote to the Center from the Louisiana Penitentiary: "PLEASE I beg you to help me, and talk with me. I'm truly afraid to die, Louisiana Penitentiary is a very dangerous place for a 16 year old to spend the rest of his life."

Johnny was convicted of the July 1974 rape of a white woman. The two men who abducted her dropped her off near John-

ny's home. In describing the rapists, an eye-witness said one was 19 or 20, 5'7" tall, and 145 pounds. The other was 20 or 21, 5'9", and 160 pounds. Johnny was 5'4', 130 pounds, and 15 years old. The police attempted to charge his younger (13 year old) bro-

He refused to sign the confession which he could neither read nor understand; relenting only when he was severely beaten by the police.

The trial was filled with conflicts in testimony. The raped woman testified that Johnny could not have been a participant. The jury deliberated 90 minutes and returned a verdict of guilty. The judge sentenced him to death. He is now serving a sentence of life imprisonment; Louisiana's death penalty is currently surpended due to Supreme Court rulings.

Several questions were raised by Johnny's case Why was one man convicted for a crime two men committed? Shouldn't society be responsible for the safety of the inmates of its prisons?



Berger to Perform "Mime On Campus"

Keith Berger, an accomplished mime, will present 'Mime on Campus' on Friday, October 29th at 8:00 p.m. in Compton Auditorium. The performance will be free and is cosponsored by Student Artist and Lecture Series and the College Center Board.

Keith Berger was born in 1952 and comes from Los ANgeles. "In my early years, my imaginative life became an obsession. In the first grade I lied quite credibly, and became pro-ficient elaborating things little about. I I knew learned a little algebra to impress everyone, and received the 'top scholar' award that year at school. From there (unlike my two younger brothers - one an actor and the other studying physics at Princeton and my parents, both psychologists), my academic prowess went steadily downhill. I turned more to daydreaming and became increasingly quiet and moody. Inside me, I enacted fantastic illusions, deceptions, and characterizations - not the comic book type, yet still possessing incredible powers to overcome struggles.

"When I was exposed to theatre, I began to explore the possibility of acting out these things. I discovered that I could use my body to do it and, at the same time, show my feelings without using words - especially after I saw a professional 'living mannequin' in a store window. was fascinated, but when I asked him how he did it, he told me to get lost .-I discovered that people shared my fascination for performers such as Rudolf Nureyev and the late Bruce Lee who executed 'physically incredible' movements in an emotionally identifiable and inspiring theatrical context.

"I studied and performed as an actor, clown, and dancer. As a teenager, I

saw Jean-Louis Barrault in Les Enfants du Paradis and decided that I would become a performer of mime. I taught myself the basic elements of classical French pantomime and other movement and acting disciplines - some of which I observed from the Orientals, such as kung-fu. My most profound influence came from Paul Curtis, Director of the American Mime Theatre - a fascinating and exacting discipline totally different from that of schools." the French

In New York City, Keith Berger became famous as a street mime, performing at the Plaza Fountain, in front of Fifth Avenue's St. Thomas Church, and in Washington Square. Hebegan out of necessity, in order to get money for food, and has been ticketed by the police, carried for two blocks over the shoulder of a fat lady, and repeatedly given money by kind New Yorkers. Keith still appears on the streets, no longer out of necessity, but to relate to the city and its people. He can be seen on New York City streets pulling cars with imaginary ropes, directing traffic, building walls and then opening the door for cars to come through, bullfighting cars, and occassionally hanging himself in front of them ( especially squad

"One Sunday at the Plaza Fountain I caught a heavy after-church crowd. Among them I noticed a young boy, in a wheel chair, who seemed so fascinated that I was compelled to approach him as a 'mechanical man'. I held out my hand to be shaken. Customarily, this action 'cranks' me down. To my horror, and everyone else's, I realized that the boy had cerebral palsy, and it looked as though he wouldn't be able to make the grab. The crowd of about 400 took a deep breath, but the boy was determined, and


I knew he would make it. The crowd went bananas when he finally did. Everyone was extremely turned on-especially the kid and me."

Throughout the United States and Canada, Keith Berger has presented "Mime on Campus," which entails a formal stage presentation as well as appearances in cafeterias, student unions, and classes-wherever students congregate. For two consecutive years, he showcased before the NEC (National Entertainment Conference, world's largest organization for booking performing artists on college campuses). In addition to receiving foir standing ovations in one twenty-minute performance, Keith's popularity caused the NEC to recognize an additional performing category in the Fine Arts: music, dance, theatre, and now, mime.

In New York City, Keith Berger has appeared at the Mercer Arts Center, Bernard Barauch College, Queens College, and the Cathedral of Saint John the Divine. Of his Lincoln Center show ("Mime over Matter"), performed three times in Alice Tully Hall, reviewers said: "The perfection of every little move ... ingeniously packs the empty state." (New York Post) "He is handsome, brilliant . . . a polished virtuoso and insightful commentator on the human condition." ( Newhouse Newspapers)

As actor, director, and writer, Keith has directed his own mime play, Interruptions, and starred in several films: Angels, produced by Jape Productions; and Keith, one of three films he has made for Billy Budd Productions. He has also written a full-length mime screenplay, and appeared on both Canadien and American network television.




