"A Condition of Shadow"

Students Artists and Lecture Series will present Jerry Rockwood, as Edgar Allan Poe, at 8:00 p.m. in Compton Auditorium. Rockwood brings Poe to life in this one-man show created from Poes own writings. Rockwood explains the circumstances behind his acceptanced the role:

One evening my wife and I were looking blankly at each other and wondering what to do about dinner. The phone rang and on the other end was an old friend of mine, Norm Lichtblau, who was a commercial artist in Philadelphia. I was in New York. I wondered, of course, why Norm was calling me from Philly. Well, it seems he had been just reading a book of stories by Poe, and there was a picture of Poe and did I realize that I bore an amazing resemblance to Poe? Is that why he called me from Philly? Well, he went on, no one has ever done a one-man show on Poe, and it's about time someone did. I told Norm he was off his cork, hung up the phone and forgot about it.

At least for a while, I forgot about it. A week later I discovered myself in a library, peculiarly drawn to the shelf of Poe books. There he was. My God, he did look like me. Or I Admission is free.

On Tuesday, March 24, the like him. I found a description: we were exactly the same height - 5'8"- dark hair and eyes.

> I started to read all his stories, looking for things I might do well. At the same time I went to work on his biographies and soon was hooked. The man's life was incredible. A tortured soul struggling against a very alien world. I became more and more intrigued with the idea of a one-man show that would be a revelation of the man's life, and not just a collection of readings.

> I pored through his letters, his essays, even found marginal notes - and chose material which offered insights ot his being.

> The performance moves from the light side of Poe, through his strange marriage, his frustration at not being able to have his work published, his escape into drink and his eventual insanity and destruction. It is an exhausting performance. But one of the most exciting projects I have ever undertaken. Thanks to a chance phone call.



The contest is open to anyone who cares to participate, but members of FSC, and people of the area, are particularly encouraged to participate. One of the major reasons of the existence of NIGHTSUN is the attempt to intensify the artistic and intellectual life in our community. There are many creative and highly talented people in this area, but often they live and work in isolation from each other, while looking expectantly to the distant centers of cultural life. The editors of NIGHTSUN hope thatwe can find ways by which people of this area toward each other, to make things happening right

Entries for the contest can deal with any topic, but the next issue of NIGHTSUN will primarily deal with the theme 'Patriotism and the American Interest.' This theme, reflecting a major concern of the majority of people in this country, should be approached in many ways.

Contributions need not be explicitly political, and they will not be judged by their political preference. All they should do is shed some light on the American experience, or on the future relations of the USA to the rest of humanity.

NIGHTSUN is not the expression of a fixed, unified opinion, but more the meeting place of conflicting persuasions. emphasizes dialogue, not statement. There is a tendency that people retreat into groups of people who share their opinion, thereby isolating ehemselves frome the rest of society, and losing the capacity to even clearly formulate or defend their attitudes. There is also a tendency of academic departments to isolate themselves from each other-something that easily leads to intellectual stagnation. It is one of the major goals of NIGHTSUN to conteract these kinds of social isolation by focusing on the things that might divide us.

Ms. Jean J. Pollock, a specialist in individual, group and family psychotherapy will present a lecture on art therapy at Frostburg State College on Wednesday, March 18, at 7 p.m. in the Fine Arts Gallery.

Ms. Pollock is presently employed by the Garrett County Health Department as a clinical consultant and supervisor, as well as a transitional coordinator responsible for coordination of services between Garrett County Mental Health and Thomas B. Finan Center, and hospital case coordinators and individual community therapists.

She established and concucted an art therapy program for Prince George's County in its patient psychiátric unit. She supervised, trained and coordinated volunteers in art therapy as well as supervised art therapy practicum for students from Towson State University, Goucher College and George Washington University.

Additionally, she has presented many art therapy workshops including a presentation titled "Psych-social Needs of the Elderly" for the Dennett Road Nursing Home and a special weekend presentation, "Mandala Seminar" at the Atlanta Art Therapy Institute.

Prior to coming to this area, she worked for four years at the Spring Grove Hospital Center as an art therapist and in Italy as a voluntary, part-time, co-therapist in alcoholism groups for the Office of Human Relations, utilizing art therapy techniques for the rehavilitation of servicemen and their families.

She received her Master of Arts degree in Developmental Clinical Psychology from Antioch College in Columbia, MD, and her Bachelor of Fine Arts degree from the Maryland Institute College of Art in Balt-

The vaulting event was led by Koelliker for FSC with a 7.95 (1st place was an 8.6) for 27th place. Sippel was 31st with 7.9, Sharp 35th with a 7.85, Young 37th with 7.8, and Buck 39th with a 7.7.

On the uneven bars, Sippel almost made finals with a 7.6 for 11th place. Koelliker had a 6.15 for 29th, Young a 6.15 for 32nd, Juli Brode a 5.9 for 34th, Sharp a 5.7 for 39th.

"Le Malade Imaginaire"

The FSC French Club will present Moliere's "Le Malade Imaginaire" ("The Hypochondriac") on April 2 and 3 at 2:30 p.m. in the Allegany Hall gym. The college community is invited to attend on April 2. Synopses in English will be given before each act, and admission is free.

The three-act satirical comedy, directed by Mrs. Dottie Kerbow, concerns the plight of a self-made invalid who arranges to marry his daughter to a doctor so that he can receive free medical treatment. Overly concerned with his imaginary illnesses, the hypochondriac is unaware of his wife's indiscretion and of the plot which she and her lover devise to obtain his family fortune.

In this play, Moliere bitterly attacks quackery and hypocrisy in the medical profession and unmercilessly portrays doctors as incompetent, ruthless, sadistic monsters who administer anything as long as they are paid for their services.

J.B. Poquelinet portrays the ailing Argan, a grumpy, complaining man who demands attention from everyone. The impertinent nurse and servant, Toinette, performed by Pat Gilroy, makes Argan's life miserable at times and she often receives the fury of his fiery temperament. Nevertheless, she sincerely cares about the welfare of her master and his family and is committed to preventing Argan from making mistakes, such as marrying his older daughter to a man whom she does not love. Louison (Carey Blevins), younger daughter of Argan, fears her father's switches and reluctantly reveals to him the identity of her sister's true love.

Beline (Barbara Belland), wife of Argan, schemes with her lover Monsieur Bonnefo (Kevin Burns) to obtain her husband's money after they have learned that he is not really ill and is far from being on his deathbed.

Angelique (Anne Valente), Argan's beautiful daughter, falls in love with Cleante (Jesse Myers) when he rescues her from street ruffians. Disguised as Angelique's voice teacher, he gains entry into her house and learns that her father has promised her in marriage to a doctor, Thomas Diafoirus (Lisa Fuller), son of Monsieur Diafoirus (Chris Teets) also a doctor. Monsieur Purgon (Sam Randall) serves as Argan's personal physician, and Monsieur Fleurant (Robert Riggs) administers Argan's medication and enemas.

Beralde (George Orvis) visits his brother Argan and, on behalf of his niece, tries to persuade him not to persist in forcing the ridiculous marriage of Angelique to Thomas Diafoirus. Beralde also insists that his brother is not really ill. To convince Argan that his doctors are making a fool of him, Beralde and Toinet; te invent a plan to reveal the hypocrisy of those whom Argan trusts.
