I am, as a write in candidate, running for Student Union President. Experience is the main qualification to be considered in this office, since to fill this office and execute its duties a candidate must have a complete and working knowledge of S. Having served in student union four semesters as an alternate or a full time representative, there are a number of programs I would support to make it a better organization. U. more authority to carry out its purpose. Next there is a need to widen poster policy to be more inclusive in its scope. Perhaps the greatest thing of universal interest is the S. U. Building Although it will not be a reality for many years, now is the time to be sure it will include what we students want. With the proposal now in the desk of the trustees, the time has come to move! There are many other things to be done. such as correcting the technical with Sunday movies, adopting guidlines for a temporary charter group to prove it has been active, a cable for the television in Gunter, S. U. actively supporting and aiding in the near extinct book exchange, or even the possibility of a campus radio station based in the S. U. building. In closing, I will remind you of the duties of S. U. President in addition to chairing weekly meetings. He is a voting member of Executive Council, a responsible job which requires conscientious discrimination of things that come up and how they will affect our campus. Editorial Comment We Recommend Thomas Smith

The present editor and the editor of next year's student newspaper, State-To-Date, sincerely believe that Thomas Smith should be elected as Chairman of the Judicial Board. This decision was reached after a considerable amount of thought and discussion and is as objective as the editors could possibly make it. Each candidate was interviewed at length by the editors and all statements submitted by the candidates were carefully read. Each candidate was asked the same questions and allowed to talk freely. We do not wish the student body to vote for Tom Smith solely because we say so, but we think we should present the reasons why we honestly feel he should be elected Chairman of the Judicial Board.


Tom Smith is the most capable and decisive of the candidates. He has weighed all functions of the Chairman of the Judicial Board and feels the office is a dynamic position, the duties and responsibilities of which can be divided into three categories, the administrative, the diplomatic, and the functions as a member of the Executive Council. The administrative duties would be conducting and guiding the actual meetings once a week. Equal justice for all students will be the guideline of the Board. Mr. Smith has a thorough understanding of constitutional law which will enable him to fulfill this function. He also feels that the Chairman should be a laison between the student body and the administration. He has already laid the groundwork for this diplomatic position by conferences with different members of the administration. He has sought out the opinions of the administration concerning Judicial Board, and discussed with them the powers and functions of the Board. He is also willing to assure that the rights of all students will not be infringed upon and is willing to maintain the position of the Board when it is threatened. As a member of the Executive Council, Tom Smith will energetically work for the good of the students on issues such as depositing the Student Association activities fees in local banks. If elected, he would like to testify before the Maryland legislature in an effort to bring the funds to a local bank. We firmly believe that Tom Smith has, through our interviews and conversations with the three candidates most specifically and most concretely expressed his ideas, plans and expectations for the position of Judicial Board Chairman.

He also intends to implement three significant changes in the Board, if he is elected. All changes stem from the idea of equal justice for all students. He will introduce the principal of "Starre Decisis." This means that the Judicial Board will follow past precedents. In this way a student who has received censure will be able to see the basis of the sentence in similar past cases. Tom Smith will also work for the codfication of laws. There will be a maximum punishment for the infractions, and personal prejudice will not be allowed to enter into decisions. Each student will know in advance the maximum punishment for breaking the laws of the college. He will also work for an open court except in extreme cases. Students would be able to observe the Board which would contribute impartiality in the judgements. We sincerely believe that the changes Tom Smith plans to make will improve the judiciary system on this campus, and better

guarantee the rights of the students.

Of the three candidates for this office, we firmly believe Thomas Smith to be the most capable candidate for the successful implementation of a progressive and judicial system on this campus.

We have made the above recommendation in the faith that we have been as fair, unbiased, and as objective as is humanly possible. We are vitally and conscientiously aware of our responsibility to the student body of Frostburg State College. We have strived and will continue to strive Continued on Page 2

Each year, an excess of \$50,000 is "taken" from the students at Frostburg State College. This misappropriation is no secret; we all know who takes the money and where they put it. The culprit the law of the State of Marvland, that requires officials to seize student funds and deposit them in Annapolis Banks. Letter To The Editor

Dear Sir:

Your editorial entitled "Paychecks Are Trivial" in the issue of March 2, 1967, is most critical of the method of handling pay checks for employees of the State. I feel reasonably certain that you wrote this editorial without having all of the facts.

Those persons employed at Frosburg State College, working in the snack shop and bookstore, are not considered employees of the State of Maryland. These auxiliary enterprises are self-sustaining and do not appear as an item in the State Budget. The employees are paid on a contractual basis through the Central Payroll Bureau as an assurance that they enjoy the protection of Social Security. The method of payment is also a convenience for the college since it eliminates the necessity of compiling payroll data and formal reports for Social Security and income tax purposes.

This bureau has an established pay schedule which is rigidly enforced. If the necessary reports are delayed in arriving at a time sufficient to be processed, then the employee will either not be paid or his pay check is delayed beyond the designated pay day. I can assure you that every employee of this bureau endeavors to have pay checks completed on a timely basis. Occasionally, the checks are delayed by the United States Post Office. We cannot control this.

Generally, employees' pay checks for the Western Maryland area are mailed on the Monday evening preceding Wednesday pay day. On rare occasions, the checks are mailed on Tuesday evening. I feel that the Post Office Department should certainly be able to deliver to any point in the State of Maryland within 24
