Medicaid Long-Term Services and Supports in Maryland: The Model Waiver

FY 2016 to FY 2020

The Model Waiver provides services to individuals with medically complex needs and a chronic hospital or nursing facility level of care to be supported in their own homes or community-based settings.

A unique aspect of the Model Waiver is that, due to the medically complex needs of its participants, non-waiver expenditures typically far exceed waiver expenditures.

Demographics of Waiver Participants

The number of Model Waiver participants decreased by 0.9% from 218 in FY 2016 to 216 in FY 2020. More males than females were served in both fiscal years. However, the percentage of females served increased 9.9% from 91 in FY 2016 to 100 in 2020. The largest age group in both fiscal years.

Several measures remained stable, including age at fiscal year's end, waiver span, and the total number of participants.

Average annual Medicaid expenditures decreased 6.8% from \$124,718 in FY 2019 to \$116,233 in FY 2020.

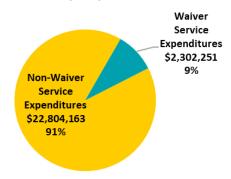

The pie chart illustrates that nonwaiver expenditures accounted for 91% of total Medicaid expenditures for the Model Waiver, while waiver expenditures made up 9% in FY 2020.

The top table shows that second and any subsequent month waiver administration had the most users (213) and was the costliest (\$1,156,000) waiver service.

The bottom table of non-waiver services shows that pharmacy & medications had the most service users (262), while EPSDT was the costliest non-waiver service (\$19,618,752).
